5. Objection to Dangerous Classification - Pehi Edmonds

Mr Edmonds voiced his concerns regarding the dangerous classification and explained to the Panel that he has lost his dog, that he did not object to the dangerous classification anymore and has accepted full responsibility for his dog's actions. He responded to questions from Elected Members concerning how the Animal Control team can help improve the complaint process.

Animal Control Manager and Team Leader – Animal Education and Control Officers took the report as read. They responded to questions from Elected Members concerning dangerous dog classification conditions, process for sworn evidence, definition of aggressive behaviour and usage of the term 'rushing' and breed of the dog.

Purpose - Take

1. To seek a determination from the Dog Control Hearings Panel on the classification of Kaiwhai (the Dog) owned by R Thompson (the Owner) as a dangerous dog.

Staff Recommendation - Tuutohu-aa-kaimahi

- 2. That the Dog Control Hearings Panel:
 - a) receives the report;
 - b) confirms it has considered the mandatory matters specified under the Dog Control Act 1996, and other matters relevant to the objection;
 - c) notes that the Dog Control Hearings Panel in determining any objection can only either uphold or rescind the classification under the Dog Control Act 1996; and
 - d) upholds the dangerous classification.

Executive Summary - Whakaraapopototanga matua

- 3. On 27 February 2024 Council received a complaint regarding Kaiwhai a tan and white Mastiff cross aged approximately 1 year and three months (the Dog). When responding to the complaint Council staff observed the Dog displaying aggressive behaviour. Refer to **Attachment 1**.
- 4. The <u>Dog Control Act 1996</u> sets out the circumstances in which Council may classify a dog as dangerous.
- 5. Staff recommend that the classification of the Dog as Dangerous is upheld.
- 6. Staff consider the decision in this report has low significance and that the recommendations comply with the Council's legal requirements.

Background - Koorero whaimaarama

- 7. On 27 February2024 Council received a complaint regarding the Dog. When responding to the complaint Council staff observed the Dog displaying aggressive behaviour. Refer to **Attachment 1**.
- 8. The complaint broadly involved a complaint of the Dog roaming on 27 February 2024, and that the Dog was known to the complainant as the Dog is out regularly barking and rushing at people. Refer to **Attachment 1** for further details.

9. On 15 March 2024 the Dog was classified by Council Staff as dangerous Refer to **Attachment 2** for the Notice of Classification.

tem (

- 10. On 26 March 2024 an objection to the classification of the Dog as dangerous was received from the Owner. Refer to **Attachment 3** for a copy of the objection.
- 11. As a result, a hearing has been convened to hear the objection. The Hearing Panel should note that:
 - i. The Owner has advised that they wish to be heard in person.
 - ii. The Complainant/witness has advised that they do not wish to be heard in person.
- 12. The normal order of the procedure of a hearing is as follows:
 - i. Opening of the meeting by the Chair;
 - ii. the Owner presents their objection and supporting evidence;
 - iii. Any witnesses in support of the objection speak to their evidence;
 - iv. The Complainant and any witnesses in opposition of the objection speak to their evidence;
 - v. Council staff summarise the Council report and makes any comments regarding information provided at the hearing;
 - vi. The Owner has the opportunity to respond to any new matters or points not already covered during the hearing;
 - vii. The hearing is closed or adjourned for a decision to be made.
- 13. For the avoidance of doubt:
 - i. The Chair of the hearing may change the order of the hearing at their discretion.
 - ii. There is no opportunity for cross examination at the hearing by any party.
 - iii. Members of the Hearings Panel may ask questions for clarification of the parties during the hearing.

Discussion - *Matapaki*

- 14. Section 33B(2) provides that in making its determination it **must** have regard to:
 - i. the evidence which formed the basis for the classification;
 - ii. any steps taken by the owner to prevent any threat to the safety of persons or animals;
 - iii. the matters relied on in support of the objection; and
 - iv. any other relevant matters.

Evidence which formed the basis for the classification

- 15. In deciding to classify the Dog, Staff have relied on the following evidence:
 - i. Council's Animal Education and Control (AEC) received a complaint on 27 February 2024
 of a known aggressive dog out roaming refer to Attachment 1
 - ii. The behaviour of the Dog noted by the Animal Education and Control Officer (AECO) who investigated the roaming. In their notes they described the Dog as displaying "full on aggression" refer to **Attachment 1.**
 - iii. A statement about the behaviour of the Dog as witnessed by the AECO Team Leader who assisted on the day refer to **Attachment 4**.

iv. That the Dog had be classified as menacing based on behaviour in September 2023 and was still being allowed to roam and behave aggressively to members of the public refer to **Attachment 5**

Matters relied on or advanced in support of the objection

- 16. The Owner(s) object to the classification on the following grounds:
 - i. The Dog was meant to be a guard dog as they have had burglaries;
 - ii. Conflict with the neighbours who tease the Dog and yell profanities at the Dog and family;
 - iii. The Dog hasn't bitten or hurt anyone;
 - iv. The Dog is only protecting his property; and
 - v. The Dog was only aggressive to AECO's because he was forcibly removed from property by an officer previously. For full details refer to **Attachment 3.**

Steps taken by the owner to prevent any threat to the safety of persons or animals.

18. Staff are not aware of any steps taken by the Owner(s) to prevent any threat to the safety of persons or animals, the Owner(s) may have further information on this matter at the hearing.

Other relevant matters

- 19. The Dog Control Act 1996 requires consideration of any other matters that the Hearings Panel considers relevant.
- 20. Council's Dog Control Policy provides direction on how Council will fulfil its legislative responsibilities pursuant to the <u>Dog Control Act 1996</u> and the Dog Control Bylaw. The Hearing Panel should consider whether its decision is consistent with the purposes in the Dog Control Policy, specifically:
 - i. the need to minimise danger, distress, and nuisance to the community generally;
 - ii. the need to avoid the inherent danger in allowing dogs to have uncontrolled access to public places that are frequented by children, whether or not the children are accompanied by adults;
 - iii. the importance of enabling, to the extent that is practicable, the public (including families) to use streets and public amenities without fear of attack or intimidation by dogs; and
 - iv. the exercise and recreational needs of dogs and their owners.
- 21. Ownership history and recorded dog behaviour can be a relevant consideration if it provides evidence of prior good or poor dog or ownership behaviour. Council has records of complaints and/or infringements regarding dogs registered to the Owner as follows:
 - i. Hamilton City Council has received nine complaints relating to the Dog between 25 March 2023 and 10 March 2024, a period of 10 months Refer to **Attachment 6.**

Options

- 22. Under the <u>Dog Control Act 1996</u>, territorial authorities have two options when considering an outcome of an objection to a dog being classified as dangerous,
 - i. to uphold the classification; or
 - ii. to rescind the classification.
- 23. There are no other options open to the Dog Control Hearings Panel under the <u>Dog Control Act</u> <u>1996.</u>

- 24. The staff recommendation is that the Hearings Panel uphold the classification for the following reasons:
 - The level of aggression from the Dog observed by Council Staff and the complainant;
 - The ongoing incidents of roaming and aggression reported to Council about the Dog.
 Council have received nine complaints in ten months, see animal history refer to
 Attachment 6;
 - iii. The young age of the dog and the level of aggression it is already displaying, see animal record refer to **Attachment 7.** The Dog is approximately 1 year and 3 months old and the first signs of aggression were reported when the Dog was approximately 6 months old refer to **Attachment 6**;
 - iv. The Owner's inaction to do anything to prevent the Dog from being able to leave the section even after a menacing classification was issued. A dangerous classification under the Dog Control Act 1996 places greater responsibility on the Owner to contain the Dog in a secure area of the property, which should restrict the Dog's ability to freely leave the property and allow safe access to the front door for visitors.

Financial Considerations - Whaiwhakaaro Puutea

25. This is a regular operating activity funded through the Long-Term Plan.

Legal and Policy Considerations - Whaiwhakaaro-aa-ture

26. There is no provision under the Dog Control Act 1996 to appeal this decision to the District Court

Dangerous dog classification

- 27. <u>Section 31</u> of the Dog Control Act provides that a territorial authority must classify a dog as a dangerous dog if:
 - i. the owner of the dog has been convicted of an offence under section 57A(2) (Rushing dog); or
 - ii. on sworn evidence attesting to aggressive behaviour reasonable grounds to believe that the dog constitutes a threat to the safety of any person, stock, poultry, domestic animal, or protected wildlife; or
 - iii. the owner of the dog admits in writing that the dog constitutes a threat to the safety of any person, stock, poultry, domestic animal, or protected wildlife.

Effect of a dangerous dog classification

- 28. If a dog is classified as a dangerous dog under section 31 of the Dog Control Act the owner of the dog:
 - i. must ensure that, from a date not later than 1 month after the receipt of notice of classification, the dog is kept within a securely fenced portion of the owner's property that it is not necessary to enter to obtain access to at least 1 door of any dwelling on the property; and
 - ii. must not allow the dog to be at large or in any public place or in any private way, except when confined completely within a vehicle or cage, without being;
 - iii. muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and

- iv. controlled on a leash (except when in a dog exercise area specified in a bylaw; and
- v. must within 1 month after receipt of notice of the classification, produce to the territorial authority a certificate issued by a veterinarian certifying
 - a. that the dog is or has been neutered; or
 - b. that for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a date specified in the certificate; and
- vi. must, if a non-neutering certificate is produced to the territorial authority, produce to the territorial authority, within 1 month after the date specified in that certificate, a further certificate that the dog has now been neutered.
- vii. must, in respect of every registration year commencing after the date of receipt of the notice of classification, be liable for dog control fees for that dog at 150% of the level that would apply if the dog were not classified as a dangerous dog; and
- viii. must not, without the written consent of the territorial authority in whose district the dog is to be kept, dispose of the dog to any other person.
- 29. A dangerous classification extends to the whole of New Zealand and remains in place for the life of the dog.
- 30. There is no provision under the Dog Control Act 1996 to appeal this decision to the District Court.

Right to make an objection

- 31. <u>Section 31(3)</u> provides a dog owner with the right to object to the classification. If a dog is classified under section 31(1)b as a Dangerous dog, the owner:
 - i. may, within 14 days of receiving notice of the classification, object in writing to the territorial authority in regard to the classification; and
 - ii. has the right to be heard in support of the objection.
- 32. The territorial authority considering an objection under subsection (1) may uphold or rescind the classification, and in making its determination must have regard to:
 - i. the evidence which formed the basis for the classification; and
 - ii. any steps taken by the owner to prevent any threat to the safety of persons or animals; and
 - iii. the matters relied on in support of the objection; and
 - iv. any other relevant matters.
- 33. The territorial authority must, as soon as practicable, give written notice to the owner of:
 - its determination of the objection; and
 - ii. the reasons for its determination.

Wellbeing Considerations - Whaiwhakaaro-aa-oranga tonutanga

- 34. The purpose of Local Government changed on the 14 May 2019 to include promotion of the social, economic, environmental and cultural wellbeing of communities in the present and for the future ('the 4 wellbeings').
- 35. The subject matter of this report has been evaluated in terms of the 4 wellbeings during the process of developing this report as outlined below.
- 36. Staff consider that the keeping of animals can enhance the quality of life and wellbeing for individuals and families; however, the Council also has a responsibility to protect the

Risks - Tuuraru

- 37. Public safety risk: If a dog that should have been classified as dangerous is not, it may continue to pose a potential threat to the public or other animals. This could result in attacks or incidents that cause harm. Failure to properly classify a dog as menacing could put public safety at risk.
- 38. Reputation and perception: Failure to properly classify a dog as dangerous may affect the public perception of Council's approach to enforcement.

Significance & Engagement Policy - Kaupapa here whakahira/anganui

- 39. Staff have considered the key considerations under the Significance and Engagement Policy and have assessed that the recommendation(s) in this report has/have a low level of significance.
- 40. Given the low level of significance determined, the engagement level is low. No engagement is required.

D17 (& D37) 27/02/2024 8.57am

Arrive in Street - sight offending dog loose at the bottom of St near its driveway. Photos taken by D37. We have herded the dog back up its driveway with the AECO vehicle (Due to previous knowledge of the dogs behaviour) to the closed driveway gate. The dogs behaviour was territorial. We have backed up to get poles out and have observed this dog go under the driveway gate so it is not contained.

Also the dog is already classified as a menacing dog based on its observed behaviour.

We have approached the driveway gate. The dog was now on its front deck barking in an aggressive manner. We have called out to the house as there was a car present. A woman has come out onto the deck gone inside and come out onto the deck again and the dogs aggression has escalated and the dog has come flying at the driveway gate towards the AECO's showing full on aggression. This has required the AECO's to yell and utilize their equipment to discourage the dog from coming off the property.

The dog owner has said the dog is only aggressive with AECU staff. It is fine with her friends and others who visit the property. She has called the dog away and after a little secured the dog. We have advised her of our observations and the complaint, and I have advised her that I will be fining her and increasing her classification on her dog from a menacing classification to a dangerous classification based on our observations. She has said that she thought this was unfair. We have departed the property and spoke to the complainant and advised him of the outcome. He was visibly upset about the dog being loose and the ongoing risk

the dog poses to people and in this case his children this morning. He is going to send photos of the dog loose via email. The photos have been received and attached as have the photos for D37. Infringement No 15126 issued for breach of Menacing Classification. Infringement No 15127 issued for failing to contain the dog to its property.

I have created a Dangerous Dog Classification and got this sworn at the District Court today. N.F.A. (-05/03/2024)
D17 11/03/2024 10.32am. Tried phoning the dog owner but went straight to voicemail again - left voicemail message about outcome.

Text also sent. "To Dog Control Officer here.

We have had another complaint about your dog roaming this morning at 5 am on someone else's property.

You need to ensure your dog is contained. Also your dog is being classified as a dangerous dog due to displays of aggression towards people. This means that your dog will need to be contained to a fenced portion of your property enabling people to get to your door without encountering the dog. Outside of this area your dog needs to be <u>muzzled</u>. Your dog registration fee will be 150% of normal."







Classification of Dog as Dangerous - Section 31 of Dog Control Act 1996

Section 31 of the Dog Control Act 1996 ("DCA") enables Hamilton City Council ("HCC") to classify a dog that it considers poses a threat to any person, stock, poultry, domestic animal or protected wildlife because of:

- a) the owner of the dog has been convicted of an offence in relation to the dog under section 57A(2); or
- the territorial authority has, on the basis of sworn evidence attesting to aggressive behaviour by the dog on 1 or more occasions, reasonable grounds to believe that the dog constitutes a threat to the safety of any person, stock, poultry, domestic animal, or protected wildlife; or
- the owner of the dog admits in writing that the dog constitutes a threat to the safety
 of any person, stock, poultry, domestic animal, or protected wildlife.

As a result of sworn evidence, HCC has classified the dog as a <u>DANGEROUS</u> dog under Section 31(1)(b) of the Dog Control Act 1996. The Notice of Classification is enclosed.

If you do not agree with the Classification, you may object in writing within 14 days of receiving the Classification. You must email your objection through to dog.registration@hcc.govt.nz. You must have valid grounds for an objection and produce evidence.

You are required, -

- (a) Within one month after receipt of this notice, to ensure that the dog is kept within a securely fenced portion of your property that it is not necessary to enter to obtain access to at least one door of any dwelling on the property; and
- (b) Not to allow the dog to be at large or in any public place or in any private way, (other than when confined completely within a vehicle or cage) without-

A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (f) above. The ranger or officer may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (f).

You will also commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you sell or otherwise transfer the dog, or offer to do so, to any other person without disclosing that the dog is classified as a dangerous dog.

As from 1 July 2006, you are also required, for the purpose of providing permanent identification of the dog, to arrange for the dog to be implanted with a functioning microchip transponder. - within 2 months after the dog is classified as menacing if your dog is classified as menacing after 1 July 2006.

If the dog is in the possession of another person for a period not exceeding 72 hours, you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. Almost Daily conflict between my self and neighbours for them teasing him and yelling profanity towards him and myself, while also threatening to slit his throat, sneaking up over driveway to light fires and up until I contacted the police 5-6 weeks ago had been lighting fireworks in our driveway at 12:30am. He hasn't injured bit or hurt anyone or anything ,if anything he's only protecting our property. We have had multiple visitors arrive here without him attacking or charging for them. When the dog control ranger had forcefully removed kaiwhai from our property (Neighbours on other side can vorge) he was removed so roughly that of course he's gonna kick up a stink. Because they had mistaken him for another dog whio looks 90% like Kaiwhai EXCEPT she's a female from a photo that they had received, who lives at the end of our driveway for him. As a result of wrongful. Identification I had to pay for him to be neutered. And got no apologies for them getting it wrong. Rhe ranger had also mentioned on a previous visit that Kaiwhai was playing with the kids down our road. So now I'm confused. So my dog he isn't as dangerous as whoever is saying he is. He actually our family dog, he's loving and playful and listens when spoken to on command. So I don't get how he can be classified as dangerous.

- I am employed as an Animal Education and Control Officer Team Leader for Hamilton City Council. I was assisting officer who was the investigating officer for a report of an aggressive dog out on February 2024.
- 2. At 8.27am the report came through as CRM#385784, the report was of an aggressive dog from Street out in the street.
- 3. The dog from this address is known to our team for previous aggressive behaviour. I have attended with to provide assistance.
- 4. On arrival to the address the dog known to me as Kaiwhai was loose in the street.
- Before even exiting the vehicle the dog Kaiwhai has shown aggression to us by barking, growling, and lunging towards us.
- 6. We have used our voices to tell the dog to go home, as the dog entered the driveway of Street (where the dog is known to live) has used the vehicle to put pressure on the dog to return to the property. Once the dog was further up the drive we have reversed back to the street and exited the vehicle with catch poles for our safety.
- 7. The dog was still showing signs of aggression.
- 8. As we approached on foot the dog has pushed back under the gate into the property, we have called out to get the attention of the dog owner to discuss the complaint and lack of containment.
- 9. As soon as the owner has opened her door the dog has come charging at the gate where we were standing. I have shouted at the dog and used my catch pole to stop it coming back through the gate or over it. The dog's behaviour was highly aggressive, I believe that it would have attacked us, if I had not used my tools knowledge and skills as an Animal Control Officer to defend myself.
- 10. After exiting the property, we have spoken to a resident in the street who has told us about multiple encounters with this dog loose in his street. I have asked him about the behaviour the dog displays and he has described the same behaviour I had just witnessed from the dog Kaiwhai.
- 11. I believe this dog poses a high risk to public safety.



1. To seek a determination from the Dog Control Hearings Panel on the classification of the dog Marlin owned by D Hockley as a menacing dog because of the observed or reported behaviour of the dog pursuant to section 33A of the Dog Control Act 1996.

Executive Summary - Whakaraapopototanga matua

- 3. On 23 February 2024 Council received a complaint regarding Marlin, a flat coated retriever Mastiff cross(the Dog), note on the desexing form the Dog is noted as an American Pitbull Terrier, who was out roaming and contained at the complainant's house. **Attachment 1** contains the investigation undertaken by staff.
- 4. The Dog Control Act 1996 sets out the circumstances in which Council may classify a dog as menacing.
- Staff recommend that the Dog Control Hearings Panel upholds the classification of the Dog as menacing because of the observed or reported behaviour of the dog pursuant to section 33A of the Dog Control Act 1996.
- 6. Staff consider the decision in this report has low significance and that the recommendations comply with the Council's legal requirements.

Background - Kooreo whaimaarama

- 7. The complaint broadly involved; A roaming dog that was on the complainant's section, unrestrained and free to leave. The complainant waited with the dog until the Animal Education and Control Officer (AECO) arrived. When the AECO arrived and got out of his vehicle the Dog has rushed at him showing aggression. The complainant has put the Dog in the AECO's vehicle as it was ok with them.
- 8. **Attachment 1** contains the investigation undertaken by staff. Key points of the investigation include:
 - i. Animal Education and Control Officer attended the job.
 - ii. When AECO arrived, they could see the Dog with the complainant at the front of the house, they have got out of the vehicle (without a catchpole) and the Dog has barked, growled, and run towards them.
 - iii. The officer has then gotten back in their vehicle and retrieved a catchpole before getting out again. The Dog has then come close to the officer showing its' teeth lunging and growling, AECO has had to use his catchpole to keep the dog away from them.
 - iv. The complainant has then said they can put the Dog in the vehicle as it is fine with them. AECO has left their lead on the ground for the complainant and returned to the vehicle.
 - v. The complainant has put the Dog in the vehicle with no incident.
 - vi. The Dog has then been taken to the Animal Education and Control centre scanned and impounded, and the Owner notified and informed the Dog was to be classified based on behaviour.
- 9. On 19 March 2024 the Dog "Marlin" was classified by staff as menacing under sections 33A (observed behaviour) of the Dog Control Act 1996. Refer to **Attachment 2** for the Notice of Classification.
- 10. On 8 April 2024 correspondence was received objecting to the menacing classification of the Dog Refer to Attachment 3.
- 11. As a result, a hearing has been convened to hear the objection. The Hearing Panel should note:
 - i. The Owners have advised that they wish to be heard in person.
 - ii. The Complainant has advised that they do not wish to be heard in person.
- 12. The normal order of the procedure of a hearing is as follows:
 - i. Opening of the meeting by the Chair.
 - ii. the Owner presents their objection and supporting evidence.
 - iii. Any witnesses in support of the objection speak to their evidence.
 - iv. The Complainant and any witnesses in opposition of the objection speak to their evidence.
 - v. Council staff summarise the Council report and makes any comments regarding information provided at the hearing.
 - vi. The Owner has the opportunity to respond to any new matters or points not already covered during the hearing;
 - vii. The hearing can be resolved to move into a public excluded session (section 48(1)(a) of the Local Government Official Information and Meetings Act 1987 and the particular

interest or interests protected by Section 7(2)(f)(ii) to maintain the effective conduct of public affairs through protecting persons from improper pressure or harassment) for a decision to be made.

13. For the avoidance of doubt:

- i. The Chair of the hearing may change the order of the hearing at their discretion.
- ii. There is no opportunity for cross examination at the hearing by any party.
- iii. Members of the Hearings Panel may ask questions for clarification of the parties during the hearing.

Discussion - Matapaki

- 14. Section 33B provides that in making its determination Council **must** have regard to:
 - i. The evidence which formed the basis for the classification;
 - ii. any steps taken by the owner to prevent any threat to the safety of persons or animals;
 - iii. the matters relied on in support of the objection; and
 - iv. any other relevant matters.

Evidence which formed the basis for the classification

- 15. In deciding to classify the Dog, staff have relied on the following evidence:
 - i. The experience and expertise of and investigation notes of the Animal Education and Control Officer who attended the complaint and observed the aggressive behaviour displayed Refer to Attachment 1.

Matters relied on or advanced in support of the objection

- 16. The Owner(s) object to the classification of the Dog on the following grounds.
 - i. That the Dog got loose accidently during a house shift when he got a fright from a loud noise;
 - ii. The Dog was frightened and didn't know the area;
 - iii. The Dog was a rescue dog who may have been beaten as a puppy and seeing the Animal Education and Control Officer with a pole he would have been scared and barked in self-defence;
 - iv. The property they are now in is fully fenced and the Dog has a steel cable run so he is contained at all times; and
 - v. Wearing a muzzle would impact the ability to run the Dog the distances they currently do Refer **Attachment 3.**

Steps taken by the owner to prevent any threat to the safety of persons or animals

17. The Owner(s) have taken the following steps to prevent any threat to the safety of persons or animals have a fully fenced section with a cable run to keep the Dog contained **Refer to**Attachment 3.

Other relevant matters

18. The Dog Control Act 1996 requires consideration of any other matters that the Hearings Panel considers relevant.

- 19. Council's Dog Control Policy provides direction on how Council will fulfil its legislative responsibilities pursuant to the <u>Dog Control Act 1996</u> and the Dog Control Bylaw. The Hearing Panel should consider whether its decision is consistent with the purposes in the Dog Control Policy, specifically:
 - i. the need to minimise danger, distress, and nuisance to the community generally;
 - ii. the need to avoid the inherent danger in allowing dogs to have uncontrolled access to public places that are frequented by children, whether or not the children are accompanied by adults;
 - iii. the importance of enabling, to the extent that is practicable, the public (including families) to use streets and public amenities without fear of attack or intimidation by dogs; and
 - iv. the exercise and recreational needs of dogs and their owners.
- 20. Ownership history and recorded dog behaviour can be a relevant consideration if it provides evidence of prior good or poor dog or ownership behaviour.
- 21. Council has five prior complaints relating to the Dog, one in 2022 for not being registered, two in 2023 for roaming and two in 2024 for roaming. Council has received one complaint after issuing the menacing classification for barking **Refer to Attachment 4.**

Options

- 22. Under the <u>Dog Control Act 1996</u>, territorial authorities have two options when considering an outcome of an objection to a dog being classified as menacing:
 - i. to uphold the classification; or
 - ii. to rescind the classification.
- 23. There are no other options open to the Dog Control Hearings Panel under the <u>Dog Control Act</u> <u>1996</u>.
- 24. The staff recommendation is **option 1** that the Hearings Panel uphold the classification for the following reasons:
 - i. Animal Education and Control staff believe the Dog may pose an ongoing risk due to the level of aggression witnessed by staff on the day he was out roaming.
 - ii. The Dog's behaviour seems to be escalating, in an earlier encounter another AECO described the Dog's behaviour as territorial Refer Attachment 4 and in the latest incident the Dog has shown aggression even when not in his own home/territory.
 - iii. The only way to reduce the potential risk of an attack is to ensure containment and to muzzle him in public. The correct style and fit of a muzzle will not prevent or interfere with a dogs' breathing during exercise. A properly fitted cage muzzle will prevent the ability to bite but allows the dog to breathe, pant, and drink water.
 - iv. Muzzling can only be enforced under the menacing and dangerous classifications of the Dog Control Act 1996.

Financial Considerations - Whaiwhakaaro Puutea

25. This is a regular operating activity funded through the Long-Term Plan.

Legal and Policy Considerations - Whaiwhakaaro-aa-ture Menacing Dog Classification

26. Section 33A of the Dog Control Act 1996 provides that a territorial authority may classify dog as menacing that has not been classified as a dangerous dog under section 31; but a territorial

authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of—

- i. any observed or reported behaviour of the dog; or
- ii. any characteristics typically associated with the dog's breed or type.

Council's Dog Control Policy - Neutering of dogs classified as menacing

- 27. Council's Dog Control Policy provides direction on how Council will fulfil its legislative responsibilities pursuant to the Dog Control Act 1996 and the Dog Control Bylaw.
- 28. The <u>Dog Control Policy</u> requires mandatory neutering of dogs classified as menacing in accordance with the provisions of the <u>Dog Control Act 1996</u>. Mandatory neutering also includes dogs classified as menacing by other territorial authorities where that dog is in the jurisdiction of Hamilton City Council.

Right to make an objection

- 29. Section 33B provides a dog owner with the right to object to the classification. If a dog is classified under section 33A as a menacing dog, the owner:
 - i. may, within 14 days of receiving notice of the classification, object in writing to the territorial authority in regard to the classification; and
 - ii. has the right to be heard in support of the objection.
- 30. The territorial authority considering an objection under subsection (1) may uphold or rescind the classification, and in making its determination must have regard to
 - i. the evidence which formed the basis for the classification; a
 - ii. any steps taken by the owner to prevent any threat to the safety of persons or animals;
 - iii. the matters relied on in support of the objection; and
 - iv. any other relevant matters.
- 31. The territorial authority must, as soon as practicable, give written notice to the owner of
 - i. its determination of the objection; and
 - ii. the reasons for its determination.

Wellbeing Considerations - Whaiwhakaaro-aa-oranga tonutanga

- 32. The purpose of Local Government changed on the 14 May 2019 to include promotion of the social, economic, environmental and cultural wellbeing of communities in the present and for the future ('the 4 wellbeings').
- 33. The subject matter of this report has been evaluated in terms of the 4 wellbeings during the process of developing this report as outlined below.
- 34. Staff consider that the keeping of animals can enhance the quality of life and wellbeing for individuals and families; however, the Council also has a responsibility to protect the community from unreasonable animal nuisances families, whanau, iwi, hapuu, and communities should be safe from dangerous animals.

Risks - Tuuraru

35. Public safety risk: If a dog that should have been classified as menacing is not, it may continue to pose a potential threat to the public or other animals. This could result in attacks or incidents that cause harm. Failure to properly classify a dog as menacing could put public safety at risk.

36. Reputation and perception: Failure to properly classify a dog as menacing may affect the public perception of Council's approach to enforcement.

Classification of Dog as Menacing Dog Section 33A Dog Control Act 1996

Section 33A of the Dog Control Act 1996 ("DCA") enables Hamilton City Council ("HCC"), to classify a dog that it considers poses a threat to any person, stock, poultry, domestic animal, or protected wildlife because of:

- a. any observed or reported behaviour of the dog; or
- b. any characteristics typically associated with the dog's breed or type.

As a result of the observed or reported behaviour HCC has classified the dog as a Menacing Dog under s33A of the Dog Control Act 1996. The Notice of Classification of Dog as Menacing Dog ("the Notice") is enclosed.

HCC requires you to have the dog de-sexed, and to provide a copy of the de-sexing certificate to HCC within one month from the date shown on the Notice.

You may be able to take advantage of discounts available through HCC for de-sexing fees with a contracted veterinarian. Microchipping is also available at the Animal Education and Control Centre. If you would like further information about these services, please contact the Animal Education and Control team on 838 6632.

Please ensure that you comply with the requirements of the classification within the timeframes outlined in the enclosed Notice to avoid any further enforcement action. If you do not agree with the Classification, you may object in writing within 14 days of receiving the Classification. You must have valid ground for an objection and produce evidence that your dog is not of a breed or type listed above.

- * For the purposes of the Dog Control Act 1996, you are the owner of a dog if:-
 - you own the dog; or
 - you have the dog in your possession (otherwise than for a period not exceeding 72 hours for the purpose of preventing the dog causing injury, damage, or distress, or for the sole purpose of restoring a lost dog to its owner); or
 - you are the parent or guardian of a person under 16 who is the owner of the dog and who
 is a member of your household living with and dependent on you.

S 33E(1) Effect of classification as a menacing dog

Sections 33E, 33F, 36A, Dog Control Act 1996

You -

- (a) must not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and
- (b) must produce to HCC within 1 month after receipt of this notice, a certificate issued by a veterinary surgeon certifying —
 - (i) that the dog is or has been neutered; or
 - (ii) that for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a date specified in the certificate; and

(c) must, if a certificate under paragraph (b)(ii) is produced to HCC, produce to HCC, within 1 month after the date specified in that certificate, a further certificate under paragraph (b)(i).

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with all of the matters in paragraphs (a) to (c) above.

A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (c) above. The officer or ranger may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (c).

You are also required, for the purposes of providing permanent identification of the dog, to arrange for the dog to be implanted with a functioning microchip transponder. This must be confirmed by making the dog available to HCC in accordance with the reasonable instructions of HCC for verification that the dog has been implanted with a functioning microchip transponder of the prescribed type and in the prescribed location.

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with this requirement within 2 months after the dog is classified as menacing.

If the dog is in the possession of another person (for a period not exceeding 72 hours), you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. You will commit an offence and be liable on summary conviction to a fine not exceeding \$500 if you fail to comply with this requirement.

Full details of the effect of the classification of a dog as menacing are provided in the Dog Control Act 1996. This is available to view online at www.legislation.govt.nz.

Right of Objection to Classification Under Section 33C

Section 33D, Dog Control Act 1996

You may object to the classification of your dog as menacing by lodging with HCC a written objection within 14 days of receipt of this notice setting out the grounds on which you object.

You have the right to be heard in support of your objection and will be notified of the time and place at which your objection will be heard.

I would like to object to my dog Marlin being classified as a menacing dog.

Marlin was picked up on Friday 23rd February 2024 from an address on Bader Street in Hamilton.

The reason Marlin was lose was because I was moving into a house in the area and it had started to rain while I was moving my fridge inside the house by myself.

Marlin was asleep at the door when I accidentally dropped the fridge, which gave him a large fright, and he was able to run out the front gate, which was open because I had my vehicle and trailer up the drive way while moving furniture into the house.

Because Marlin did not know the area and he was frightened, He ran off and I assumed was trying to make his way back to our old house. He turned up at an address on Badar street lost and upset sometime later.

The reason Dog control was called to pick up Marlin was because the lady who lived at the address was unable to contact me because I was in a meeting at work and she needed to get back to work- I missed her call by half an hour.

She left a message on my phone to say that Marlin was at her house and posed no threat to her, her two dogs or her environment, and the only reason she rang the dog control was, she was concerned that he would get run over. She said he was a beautiful dog and was only concerned about his well-being.

Marlin is a rescue dog and is very scared of anyone carrying a pole or a stick. I believe he was probably beaten with one as a puppy.

I imagine that when the dog control officer turned up to apprehend Marlin with the pole that he was very scared and began barking at the officer in self defense, So, I can understand that might have been intimidating for the officer and extremely upsetting for Marlin.

It appears the officer used great physical force to apprehend Marlin because when I picked him up from the pound he was not in a good way.

Marlin had cuts on his face, in his mouth and had a burst blood vessel in his eye. Marlin was laying on the floor of his cell shaking in a pool of his own urine, faeces and blood.

Marlin is not a menacing dog, and I am so sorry that he got out. This is my fault and not that of his own.

The property I have moved into is fully fence and Marlin has a steel cable run so he is contained at all times. He spends most of his time with me.

Generally, he goes everywhere with me or is inside, he sleeps in my bed and is the most amazing pet with my two boys who are 6 and 8 years old.

I have worked so hard with Marlin since rescuing him and he truly is an amazing, kind animal.

Please do not classify Marlin as a menacing dog for this one mistake that was my fault not his.

I do a lot of outdoor activities with Marlin- mostly running which has been a huge part of training him and if he has to wear a muzzle full time then we will not be able to run the distances we do together.

Marlin is registered, microchip and desexed and he has done the work to recover from his past life experiences and I believe he is not a menacing dog.

He is great with people, other dogs and especially children.

Marlin is a regular at cafes and public places without issue.




He has never attacked another person or animal and is my best friend.


