## 1. Purpose of the Report

2. Section 33A of the Dog Control Act 1996 ("DCA") provides that Hamilton City Council ("HCC") can classify a dog as menacing if the dog is considered to pose a threat to a person or other animal due to the dog's behaviour.
3. On 2 October 2014 Char's Staffordshire Bull Terrier Cross dog "Hine" along with her dog "Kupe" was reported by a member of the public as roaming and behaving aggressively. Animal Education and Control (AE&C) Officers responded to the complaint; both dogs were free to leave their property and "Hine" was observed rushing a member of the public by Officer D24 (Warwick) who was first on the scene and who also noted "Hine" to be displaying territorial aggression. "Hine" had to be secured at the scene and managed back at the Animal Education and Control Centre using a catchpole due to the aggression displayed and as a result "Hine" was classified as menacing.
4. In accordance with their right granted by Section 33B of the DCA the dog owner has objected to the classification of "Hine" as menacing.
5. Reference is an objection letter received from the dog owners.

## 6. Executive Summary

7. The dog "Hine" has been classified as menacing due to aggressive behaviours displayed when she was free to leave the property of 13 Lloyd Drive on 2 October 2014.
8. A member of the public filed a complaint about "Hine" and "Kupe"; noting they were roaming and displaying aggressive behaviours (CAR 107601/2014).
9. AE&C Officers responded to the complaint, those first on the scene also observed "Hine" showing aggressive behaviour; territorial and fear aggression.
10. "Kupe" was easily secured using a leash.
11. "Hine" had to be secured using a catchpole due to the aggression displayed.
12. "Hine" and "Kupe" were impounded and later collected by their owner.
13. "Hine" continued to show aggression at the Animal Education and Control (AE&C) Centre.

## 28. Key Issues

### 29. Background

- The Dog Control Act 1996 gives Hamilton City Council the power to classify any dog as menacing where an Animal Education and Control Officer has reasonable grounds to believe that a dog may pose a threat to any person, stock, poultry, domestic animal or protected wildlife.
- “Hine”, has been classified as menacing due to the behaviours she displayed on 2 October 2014 when she was free to leave the property at 13 Lloyd Drive, Nawton. “Hine” was reported as roaming by a member of the public who also noted that a neighbour on the street had yelled out to her that one of the dogs had tried to have a go at him (see CAR 107601/2014).
- AE&C Officer D24 (Warwick) was first to arrive on the scene. He saw both dogs were on the front part of the section and free to leave the property (see photo 2014/10/02 09.58am). Officer D24 also observed “Hine” rushing at members of the public on the footpath and displaying territorial aggression; hackles raised, tense posture and raised tail.
- Officer D24 secured “Kupe” in his vehicle without the use of a catchpole.
- Officer D34 (Rodney), was the second officer to arrive and also observed “Hine” displaying signs of aggression; barking, showing hackles and raised tail.
- “Hine” re-entered the rear of the property by going under the house and Officers D24 and D31 (Craig) entered the rear of the section to catch her. “Hine” was secured using a catchpole due to the aggressive behaviours that had been observed.
- Officer D24 also notes “Hine” as showing territorial and fear aggression while he was trying to secure her; hackles up, growling with teeth bared.
- Statements from all officers who attended are included in this report.
- “Hine” continued to display aggressive behaviour at AE&C Centre.

- Due to the reported behaviour outlined above, AE&C believe “Hine” poses an ongoing threat to any person or other animal so has been classified as menacing.
30. Legislative requirements or legal issues
31. Dog Control Act 1996 – Classification of a Dog as Menacing
- Section 33A of the DCA provides for classification of a dog as menacing. It gives authority to classify a dog as menacing that:  
“a territorial authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of any observed or reported behaviour of the dog.”
  - When a territorial authority classifies a dog as menacing under section 33A of the DCA the authority must give written notice (in the prescribed form) to the owner of the dog advising:
    - that their dog is being classified;
    - of the effects of the classification; and
    - of their right to object to the classification.
  - The effect of classification of a dog as menacing is that the dog must be:
    - de-sexed;
    - micro-chipped; and
    - confined within a vehicle or wear a muzzle at all times when in a public place.
32. Objection to Classification as of a dog Menacing
- In accordance with section 33B of the DCA any dog owner whose dog has been classified as menacing may object to the classification by lodging a written objection to the classification within 14 days of receiving notice of the classification.
  - The dog owner is entitled to be heard in support of their objection.
  - The email of objection to the classification of “Hine” as menacing was received on 3 November 2014. This email was received within the 14 day time-frame (attachment 10).
  - This email was acknowledged and an email was sent to Char Thompson advising of the objection process on 3 November 2014 (attachment 10).
33. Hearing an Objection to Classification of a dog as Menacing
- When considering the objection Hamilton City Council needs to have regard to the following:
    - The evidence which formed the basis for the classification; and
    - Any steps taken by the owner to prevent any threat to the safety of persons or animals; and
    - The matters relied on in support of the objection; and
    - Any other relevant matters.
  - Upon making the decision about the objection Hamilton City Council can:
    - Uphold the classification of the dog as menacing; or

- Immediately withdraw the classification of the dog as menacing.

34. Service of the Notice of Classification of a dog as Menacing

- Service of the Notice of Classification of a dog as Menacing was undertaken by Courierpost on 9 October 2014.

35. Classification of “Hine” as Menacing

- “Hine” was classified as menacing as a result of a complaint received on 2 October where “Hine” was roaming and showed aggressive behaviour towards a member of the public and the AE&C Officers who responded to the complaint
- The behaviour displayed by “Hine” during the incident included physical signs of behavioural and fear aggression; growling, tense body, hackles raised, barking and tail erect.

36. Dog Owner History

- There has been no previous history in relation to “Hine”.

37. Matters Relied on in Support of the Objection to the Notice of Classification of a dog as Menacing

- Char Thompson has objected to the classification of “Hine” as menacing on the following grounds:
  - Her personal Knowledge of “Hine”, who has not demonstrated aggressive behaviour in her presence and has been well socialised (attachment 4)
  - Letters of support attesting to “Hine’s” demeanour and Char’s character and dog ownership (attachments 5, 6, 7, 8 and 9)
- None of the items detailed above mitigate the fact that “Hine” was roaming and displayed aggressive behaviour towards both a member of the public and AE&C staff.

**38. Risk**

39. The DCA gives Hamilton City Council the power to classify any dog as menacing where the dog may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of any observed or reported behaviour. Failure to classify a dog that may pose a threat could expose Hamilton City Council to risk.



**Classification of Dog as Menacing Dog Section 33A Dog Control Act 1996**

Section 33A of the Dog Control Act 1996 ("DCA") enables Hamilton City Council ("HCC"), to classify a dog that it considers poses a threat to any person, stock, poultry, domestic animal, or protected wildlife because of:

- a. any observed or reported behaviour of the dog; or
- b. any characteristics typically associated with the dog's breed or type.

As a result of the observed or reported behaviour HCC has classified the dog as a Menacing Dog under s33A of the Dog Control Act 1996. The Notice of Classification of Dog as Menacing Dog ("the Notice") is enclosed.

HCC requires you to have the dog de-sexed, and to provide a copy of the de-sexing certificate to HCC within one month from the date shown on the Notice.

You may be able to take advantage of discounts available through HCC for de-sexing fees with a contracted veterinarian. Microchipping is also available at the Animal Education and Control Centre. If you would like further information about these services, please contact the Animal Education and Control team on 838 6632.

Please ensure that you comply with the requirements of the classification within the timeframes outlined in the enclosed Notice to avoid any further enforcement action. If you do not agree with the Classification you may object in writing within 14 days of receiving the Classification. You must have valid ground for an objection and produce evidence that your dog is not of a breed or type listed above.





A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (c) above. The officer or ranger may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (c).

You are also required, for the purposes of providing permanent identification of the dog, to arrange for the dog to be implanted with a functioning microchip transponder. This must be confirmed by making the dog available to HCC in accordance with the reasonable instructions of HCC for verification that the dog has been implanted with a functioning microchip transponder of the prescribed type and in the prescribed location.

You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with this requirement within 2 months after the dog is classified as menacing.

If the dog is in the possession of another person (for a period not exceeding 72 hours), you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. You will commit an offence and be liable on summary conviction to a fine not exceeding \$500 if you fail to comply with this requirement.

To whom it may concern.

As at 2/10/14, the AECU admin staff received a complaint of two dogs roaming in Lloyd Drive, displaying aggression to MOP's. The complaint was then dispatched to myself.

Upon arrival outside 13 Lloyd Drive, I observed two dogs from this address on the front lawn area free-to-roam. Photo taken.

I then observed "HINE" (tan / female / Am Staff cross) rushing at MOP's in an aggressive & intimidating manner. She was displaying territorial aggression, by rushing out onto the public footpath. Her hackles were up & she was all tensed up with an erect tail.

At this point in time, DCO's D31 / D34 / D35 arrived to assist. Note Kelvin (Unit Manager) also was in attendance.

I then caught the younger male dog "KUPE" & secured him in the AECU vehicle. This dog was friendly when handling.

By then my colleagues attempted to catch "HINE" in the front driveway area, but were unsuccessful, as she just ran rapidly past them.

Then "HINE" managed to wriggle under the dwelling house & got into the rear section of 13 Lloyd Drive. She was then caught using the catching pole by myself, with the assistance of D31 (Craig). "HINE" displayed territory & fear aggression while trying to catch her. She had her hackles up, was growling, with her teeth bared. Throughout the process of handling "HINE", she had to be 'poled' for DCO safety. Photo taken.

Classification on behaviour of the dog Hine from 13 Lloyd Drive, Hamilton.

On the 2/10/14 at about 9.55am I attended the property to assist D24 as there were two roaming dogs reported in the street.

When I arrived (I also had Kelvin Powell with me as he had come out on the road with us) I sighted two dogs roaming and D24 was in the process of catching the younger male dog which came to hand.

The second dog which was Hine wouldn't come to hand but started to act defensive towards all of us present; she showed signs of aggression towards us at first she started to bark and was in a heightened awareness showing hackles, raised tail. D31 and myself approached her with our catching poles to try and secure the dog but as we got closer the dog ran back onto its property on the driveway area. The whole time it was trying to run away and to avoid us. The dog was showing more fear/flight at this point. We couldn't get near enough to catch. At this point the dog went through a hole that had been made under the side of the house by the front entry door and came out on the other side of the house and into the rear yard.

D31 & D24 jumped over the fence and caught the dog on the pole from the rear deck as it had gone up on this.

The dog was then put in the work vehicle and we left the property.

RE: Objection to Classification

I am the co-owner of Hine, alongside my husband Corey. We have owned Hine since she was a young pup at 8months old.

We came across her ad on TradeMe, her previous owner looking to rehome her. She was living in Cambridge as a gift for a lady's son and because the son grew tired of her, she needed to find a new home - that's where we came in.

We made the trip to Cambridge with our boy Kupe to meet her and see if she would get along with him. When we got to the property she was on a chain connected to a run. As soon as she saw our car pull up she started barking. She has always been a very vocal dog!

We introduced ourselves, and then introduced our boy Kupe. She greeted us happily from the moment we met her so we decided to bring her home.

When we brought Hine home we noticed the front area of her neck was widely raw from being chained 24/7 and she had a lot of energy. Together with our boy Kupe, we managed to get her back to a good healthy condition, and began to socialise her by taking her out on public walks, and eventually taking her to a regular pack walk to interact with other people and a variety of other dog breeds.

In the whole time we have had Hine under our ownership, she has not once shown aggression towards another living being. Hine is desexed, regularly vaccinated and flead, microchipped and registered on both the national animal registry, and the local council registry. She is a house-broken dog who loves to have cuddles with my husband and my 3 year old daughter. Hine has the utmost love and feeling of duty towards my 3 year old daughter and is always watching over her when she plays outside. Hine likes to run on wide plains and has developed the courage to swim in the water after enjoying playtime in the water with other dogs that she met down at the river. Hine is great with people and has had many strangers approach her to interact and give her a pat, including children, not one of them feeling threatened by her. Hine is also learning to be a good mentor to other high-energy dogs, being one herself. She knows how to correct dog behavior and help get other dogs in to a calm submissive state. Hine has met a lot of great people and wonderful dogs through socialising on pack walks both on and off lead, and also just during general lead walks in public places. Hine even likes to show affection to my cat, although my cat doesn't feel the same about her. Hine has always been welcoming to our home visitors and likes to rub against them for pats and lick their faces. Hine likes to communicate by being vocal and on the odd occasion people may misconstrue this as a sign of aggression but it is just her way of communicating as she is very vocal.

As you can appreciate, we love our girl very much and we believe that we are providing a stable, secure, quality environment for her to learn, grow, thrive and live happily.

Moving to the time that Hine was impounded and classed as menacing, the day being Thursday the 2<sup>nd</sup> of October 2014.

First and foremost, I acknowledge that Hine and Kupe were roaming within the vicinity of our property and were not contained as is a requirement for all dog owners. I completely accept this fault and apologise for the fact that they were able to put themselves in a position where they were freely roaming in a public place.

As a responsible dog owner, we had originally put measures into place that we felt were sufficient to contain our dogs while we were at work during the day. We have high fencing and two gates that were latched and padlocked at the time of the incident. Unfortunately, our dogs still managed to dig a hole under my deck, then gaining access to the area under my house. Because there was a small gap in the exterior boarding of the area under the house, they managed to squeeze under this to the freedom that was waiting for them. My husband and I rectified all notable areas as soon as they were identified. We also notified our landlords and are still waiting for a permanent fix to be made to all notable areas that would prevent any further digging.

I would like to thank the Animal Control staff who managed to safely detain my dogs without the need of further more permanent actions. I appreciate that the work that they do can be very demanding in some cases and that they can be met with some hostile situations and unpleasant people.

Based on the report I received, I would like to highlight a few items contained within, and some not:

Under the *Request Details* of the Animal Complaint, there is mention that the dogs ran down Lloyd Drive onto Crawshaw Ave. I have two witness accounts from neighbours who both confirm that the dogs remained within a 100 meter radius of our property the whole time. Verified by Trish at 16 Lloyd Drive and Justin at 15 Lloyd Drive

Under the *Request Details* of the Animal Complaint, I have further verified with my neighbour Justin residing at 15 Lloyd Drive (mentioned in the report) that my dog Hine did not try to "have a go at him" but did in fact communicate with him by barking when he tried to call her over. I further confirmed that he "would not class her as aggressive" and that when he "tried to call her, she barked". We also discussed that the day prior was the day that a dog owner was attacked on Avalon Drive by their own dog which was a bull breed.

Under the *Animal Enquiry* information lodged for both Hine and Kupe, the notes question the validity of the ages of both of my dogs. I would like to remind the council and staff that my husband and I have had both of these dogs under our care since they were puppies and we know how old they are. Kupe is not younger than what is stated, and Hine is not older than what is stated. We went through our history in obtaining the dogs to confirm that we had provided the correct information and this is still the case.

Under the Notes written describing the events that took place on the day, I would like to address the process that was followed at the time and the information supplied on the report. If this information could be clarified during this hearing I would greatly appreciate it.

- Was there any reason why 3 different units needed to respond and turn up to the complaint about my dogs roaming? If so, what was that reason, and why were there 5+ control staff attending to the call out?
- Not included in the report I received, is that at least 5 control staff were unable to detain Hine when they first arrived because she ran back under the house. Instead of

trying to make contact with me and allow me a chance to cooperate and be aware of what was happening, the control officers decided to lift my heavy duty gate off its hinges, damaging the hinge placement in the process. In total there was almost 30mins spent at my property trying to detain the dogs. Was there any reason why the last resort was removing our newly installed gate from its hinges and compromising the workmanship of our landlords?

- This was the first offence for the year of either of my dogs and we did not receive a warning or any further information other than the letter stuck on our front door saying our dogs were immediately impounded. Is there any reason why this particular action was the only action taken?
- I had all of my contact information and my husbands cellphone number listed in our registration details for both of the dogs. They are both microchipped and at the time of the impoundment they were both microchipped, yet not one officer tried to contact myself or my husband through any voice channel – there were no missed calls and no voicemails for any of our contacts that we registered with at all on the day. Why was there no attempt to contact us and let us know our dogs were roaming at the time of the incident? Is that not one of the reasons why we have to provide so many details when registering our dogs?

I would like to reference a recent case of the same nature where a Siberian Husky named Storm was classified as menacing. Storm has been classified as such because Storm roamed onto a paddock owned/operated by an Early Childhood Education Centre, and storm attacked the centres pet sheep, drawing blood. It took centre staff 30 minutes to get Storm off the sheep and into a vehicle. This whole attacked occurred in front of Centre Staff and the children.

Hine has been grouped into the same category as this husky, even though Hine is still yet to attack any living being.

Based on the report, the reason why Hine has been grouped into the same category is purely because she “showed signs of territorial and fear related aggression” – this is the same dog that witnessed her brother being taken away, witnessed a group of complete strangers break onto the property she knows as home by removing a very solid and contained gate, and in such a stressful situation then had to deal with multiple agents taking a front-on approach using catch poles to detain her. I have never known a control officer that has done as such in the past, without attempted contact of the owners, and without possibly breaching some private property restrictions? I don't know, I'm just a general member of the public trying to fight for my dog.

I completely accept full responsibility that at the time of the incident the property was not able to contain the dogs, but the steps taken to address this issue I believe could have been different and could have resulted in a more desirable outcome. I do not place blame on any staff that attended the roaming complaint on that day, but I would do express concern in the steps taken that day.

Hine is still currently undergoing obedience and behavioural training with my husband and I as her owners, in consultation and regular contact with a dog trainer and a behaviouralist. Again, both whom agree that Hine is not an aggressive dog and do not agree with the classification as menacing placed upon her.

I have consulted with all of my surrounding neighbour's, being the follow residential numbers at Lloyd Drive in Nawton (all re-confirmed 31/01/2015):  
11, 11A, 15, 12, 14, 16

I have confirmed that the neighbours in all dwellings have no issues with our dogs on the property (including Hine) provided we have taken all of the appropriate measures to contain

them within the property. We have already taken steps to ensure that this is the case, and we will continue to keep it this way in all instances.

I would like to request that this classification be dismissed as I feel it is unjust having to classify my girl as something that she is not based on one incident that could've been handled in a different way. I have multiple references of people that I have been privileged to meet through Hine herself, socialising with other dogs and other dog owners. I have provided support letters from others whom I would not have met without socialising her, and I have many other contacts I have gained through both of my dogs who are happy to be character references and provide behavioural observations/assessments.

I thank the Animal Control team for safely detaining my dogs until the next day when I was able to retrieve them, the Manager for allowing me the opportunity to object to the classification, and I thank you the Committee for considering my request. To whom it may concern,

I am writing this letter in support of the dog named Hine, and her owner Char Thompson.

I have known Hine for over a year now and her owner for almost 5 years.

I have been a dog owner for nearly 13yrs, and my family has had dogs as far as I can remember for all of my life. I have also been around variety of breeds of dogs thru friends and families for many years.

I have done the Animal Care Course thru CPIT (which includes two levels of training in Animal Behaviour that was taught by a certified behaviouralist) and also recently volunteered with the dogs at the SPCA for over a year, where I worked with a number of dogs with differing personalities and behavioural issues.

In the time I have known Hine she has never shown any signs of aggression or dominance, is always friendly and of a calm demeanor. She has socialised with me and my parents dogs on a variety of occasions at dog parks, the river both one on one and with other dogs and their owners and she has only ever shown an interest in getting to know the other dogs, playing and having fun. I have also had the privilege of seeing her at other animal events such as the weekly pack walks hosted by Hamish Young (aka the Dog Dude, from Cambridge) where there are dogs of all breeds, shapes and sizes and people of all ages, sizes and races.

In all of these situations Hine has never shown any sign of aggression or dominance, she is friendly to all, both dog and human and just loves to socialise.

Her owner Char is known as an open, honest, friendly and down to earth person that loves her dogs and will do anything to keep them safe. I know that when she was looking for a new property for her family and the dogs she to move to, she made sure that the property was fully fenced to a good height that would keep the dogs secure while she and her partner were not home.

If there was any areas that allowed the dogs to escape the property she and her partner would work to resolve this immediately so that they continued to keep the dogs contained and safe.

I am of the belief that any dog that watches its playmate and family member be put into a strangers vehicle (in this case the council truck) and then once on her own property watches these same people break into her backyard and then bail her up with catch poles will react in a protective, scared and defensive manner. I do not agree that she is an aggressive dog and does not deserve to be classed as Menacing as this is not appropriate in this situation.



I had met Hine three times and the first time very shortly after she was picked up by Char and Corey. I went over for dinner patted her once or twice and went on my way home, happy to see Hine in a new loving home. I also met Hine when owners were at work, I greeted them both positively and after a second pushed my fingers through the gate and told both dogs I was about to enter their yard. Kupe greeted me like a happy sausage even though he hardly knew me and Hine soon after. Hine was a chain dog to my knowledge before finding refuge with Char and Corey and was quickly becoming aware of her new found freedom and loving it. I have never seen any signs of aggression from Hine in fact she is a lovely cuddly friendly girl who romps with toddlers and is not shy of meeting new people.

She regularly socialises with other dogs as both owners are in dog clubs and has never ever shown me or my child any signs of aggression. She is owned by responsible good hardworking people who only want the best for their dogs.

I do think any sudden movements loud voices and the notion of being held on a pole, definitely added to her stress the day she was seized, as any dog who needs the pole would seem. The dog was clearly fretting and reacting scared as such after the intrusion to the yard. It would be an injustice to place a menacing dog label on this dog for one small adventure that didn't go so well.

When AECU staff collected the dogs Hine showed aggressive behaviour which has led to her being classified as menacing.

Hi Susan,

I am emailing you because I have been told that I need to get in contact with you in order to get information that I have requested.

My two dogs were impounded from my property at 13 Lloyd Drive in Nawton on Thursday the 2nd of October just after 10am while I was at work. I haven't been given any information that details facts about what happened on the day.

I went and got my dogs out the following day 3rd of October and shortly after received a notice from the council advising that my female was classed as menacing, further requesting the desexing certificate and that I comply with council rules as per the dog control act.

I took the desex certificate into the animal control Centre on Saturday the 11th of October and at this point I asked Paul (the man behind the counter) for a summary of facts specifically identifying the events that led up to my dogs being impounded and how it was established that my female was menacing. Paul said that the officer that took my dogs was on duty that day (the 11th) and said once he gets in, Paul would ask him to email me the facts.

I have still not heard from anyone from Animal control so I called the office today and a lady named Julie said that I actually need to email you to request information that is held on file for me and my dogs. Julie gave me this email address to write to, so here I am.

I would like to request a copy of the full story explaining all of the facts leading up to my dogs being taken.

All I know so far is that a lady called the pound because my dogs were loose (they got out under the house), the animal control officers took my heavy duty gate off its hinges to take the dogs when they got back under the house and on the property (and they have not provided compensation to my landlord for the pieces they broke) and they slapped a letter on my door to say the dogs are gone.

I have asked for detailed facts because I have been regularly training, attending pack walks and socialising my dogs since they were puppies, and the dog behaviouralist that I work with wants to know how it came to that my female was classed as menacing. I would also like to know this as well.

My dogs are Hine (female American Staffordshire Terrier) and Kupe (American Bulldog Cross). I also note that the animal control office have my dogs registered under the wrong breeds and would like to know how I get that updated please. If you need any further information from me please feel free to contact me 0210622583. My details are on file as both of my dogs are registered and microchipped.

## 1. Purpose of the Report

2. Section 33A of the Dog Control Act 1996 ("DCA") provides that Hamilton City Council ("HCC") can classify a dog as menacing if the dog is considered to pose a threat to a person or other animal due to the dog's behaviour.
3. Chika" has been classified as menacing by HCC's Animal Education and Control Unit as on 11 December 2014 John Taylor's dog "Chika" chased and killed a Chihuahua named "Lulu" belonging to Christina Campbell of 12 Valley Tce, Hamilton. Also on 12 December 2014 when Animal Control Officer visited the dog owners "Chika" did display aggression towards the officers even though being held on a leash by her owner.
4. In accordance with their right granted by Section 33B of the DCA the dog owner has objected to the classification of "Chika" as menacing.
5. The Subcommittee is asked to consider the classification of "Chika" as menacing based on the evidence attached and presented at the hearing.

## 6. Executive Summary

7. The dog "Chika" has been classified as menacing as a result of a complaint received on 11 December 2014 in which "Chika" chased and killed a Chihuahua named "Lulu" and due to the aggressive behaviour displayed toward animal control staff when they visited the dog owner to seize "Chika" the day after the attack.
8. The attack by "Chika" was swift and over in moments.
9. "Chika's" owner does not deny his dog killed "Lulu" but alleges the attack occurred after "Lulu" left the property of 12 Valley Terrace and barked at his dog.
10. Christina "Lulu's" owner does not believe "Lulu" left the section but does admit the gate was open at the time.
11. Whether "Lulu" left the property or not the attack occurred and resulted in the death of a dog, but due to the gate being open Animal Control made the decision to classify "Chika" as menacing and issue an infringement rather than seek destruction of the dog "Chika".

**12. Recommendations from Management**

**24. Key Issues****25. Background**

- The Dog Control Act 1996 gives Hamilton City Council the power to classify any dog as menacing where an Animal Education and Control Officer has reasonable grounds to believe that a dog may pose a threat to any person, stock, poultry, domestic animal or protected wildlife.
- “Chika”, has been classified as menacing due to the behaviours she displayed on 11 December 2014 when she chased and killed a Chihuahua named “Lulu” from 12 Valley Tce, Hamilton and due to the aggression displayed to Animal Control Officers on 12 December 2015 when they visited the dog owner and seized “Chika” pending the completion of the investigation (attachment 1).
- John and Sharon Taylor had put their dog “Chika” in the car, which was parked in the Graham Park driveway, when “Lulu” allegedly ran across the road barking. “Chika” has then jumped out of the car and chased “Lulu” back to her property where she has then attacked “Lulu”.
- John noted he ran after “Chika” but by the time he caught up with the dogs it was too late.
- The attack is reported to have occurred around the front porch area of 12 Valley Tce (attachment 2).
- The attack was over in moments but resulted in the death of “Lulu”. “Lulu” died instantly and her owners describe her as bleeding profusely and her intestines hanging out (attachment 3).
- John does not deny that his dog killed “Lulu” but blames “Lulu” for the attack as she left her property and barked at “Chika”.
- Christina Campbell, “Lulu’s” owner notes it is highly unlikely that “Lulu” left the property but does admit the gate was open at the time of the attack.
- Christina was in her kitchen when she heard a commotion and looked out her window to see a man and dog coming onto her property. Christina then ran outside to the front of her house to find “Lulu” dead and John taking “Chika” back to his car (attachment 5).
- A complaint was lodged with Animal Control on the evening of the attack and the investigation commenced the next morning.

- Dog Control Officers visited John Taylor and seized “Chika” pending the outcome of the investigation. While they were at the property “Chika” showed aggressive behaviour towards them despite being on a lead and under control of the dog owner (attachment 4).
- Whether “Lulu” left the property or not the attack occurred and resulted in the death of a dog, but due to the gate being open Animal Control made the decision to classify “Chika” as menacing and issue an infringement rather than seek destruction of the dog “Chika”.

26. Legislative requirements or legal issues

27. Dog Control Act 1996 – Classification of a Dog as Menacing

- Section 33A of the DCA provides for classification of a dog as menacing. It gives authority to classify a dog as menacing that:  
 “a territorial authority considers may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of any observed or reported behaviour of the dog.”
- When a territorial authority classifies a dog as menacing under section 33A of the DCA the authority must give written notice (in the prescribed form) to the owner of the dog advising:
  - that their dog is being classified;
  - of the effects of the classification; and
  - of their right to object to the classification.
- The effect of classification of a dog as menacing is that the dog must be:
  - de-sexed;
  - micro-chipped; and
  - confined within a vehicle or wear a muzzle at all times when in a public place.

28. Objection to Classification as of a dog Menacing

- In accordance with section 33B of the DCA any dog owner whose dog has been classified as menacing may object to the classification by lodging a written objection to the classification within 14 days of receiving notice of the classification.
- The dog owner is entitled to be heard in support of their objection.
- The letter of objection to the classification of “Chika” as menacing was received on 22 January 2015. This letter was received within the 14 day time-frame (attachment 6).
- This letter was acknowledged and a letter was sent to John Taylor advising of the objection process on 2 February 2015 (attachment 7).

29. Hearing an Objection to Classification of a dog as Menacing

- When considering the objection Hamilton City Council needs to have regard to the following:
  - The evidence which formed the basis for the classification; and
  - Any steps taken by the owner to prevent any threat to the safety of persons or animals; and

- The matters relied on in support of the objection; and
- Any other relevant matters.
- Upon making the decision about the objection Hamilton City Council can:
  - Uphold the classification of the dog as menacing; or
  - Immediately withdraw the classification of the dog as menacing.

30. Service of the Notice of Classification of a dog as Menacing

- Service of the Notice of Classification of a dog as Menacing was undertaken by Courierpost on 13 January 2015.

31. Classification of “Chika” as Menacing

- “Chika” was classified as menacing as a result of a complaint received on 11 December 2014 where “Chika” had chased and killed a Chihuahua named “Lulu” and due to the aggression “Chika” displayed when seized by Animal Control Officers the day after the attack (attachment 8).

32. Dog Owner History

- There has been no previous history in relation to “Chika”.

33. Matters Relied on in Support of the Objection to the Notice of Classification of a dog as Menacing

- John Taylor has objected to the classification of “Chika” as menacing on the following grounds:
  - “Chika” comes from docile and tractable breeds
  - Has completed obedience training
  - Lives with cats and has never been aggressive to them
  - Walks quietly on lead and is not aggressive to other dogs
  - Has not come into season for two years
- None of the items detailed above mitigate the fact that “Chika” chased and fatally attacked a Chihuahua named “Lulu” on 11 December 2014 and showed aggressive behaviours toward Animal Control Officers the following day while under control of her owner.

**34. Risk**

35. The DCA gives Hamilton City Council the power to classify any dog as menacing where the dog may pose a threat to any person, stock, poultry, domestic animal, or protected wildlife because of any observed or reported behaviour. Failure to classify a dog that may pose a threat could expose Hamilton City Council to risk.



Received the job from admin.

Have put the phone number provided by the complainant into our data base and have found an animal record that matches the name of the D/O's given and also description of the dog given.

This is AN#201435- a Cattle/pointer cross tan/white named Chika owned by a John Hugh Taylor & Sharon Anne Taylor who live at 85 Dinsdale Rd, Hamilton.

**8.52am**

Rung complainant Christina and spoke to her with regards to what happened.

She said that the offending dog came onto her property and attacked her dog which was a Chihuahua which has resulted in her dog being deceased.

Christina has described the offending dog as a large-big dog maybe bull Mastiff but unsure on this. It was tan in colour short haired and was wearing a black studded collar.

The first thing she heard was someone yelling from outside as Christina was inside her house when she came out she then saw what was happening.

The offending dog owner was there and he grabbed hold of his dog and took it away.

Christina's brother obtained the dog owners name and contact phone number and also recorded the rego plate of the car. She has corrected the rego plate number given at first which was JEW339 to GEW339 as she read it wrong.

I have made a time to meet with her at 2pm later on in the day to go over with her what happened.

Christina also said that Colby from the SPCA came over and now has the deceased dog.

**9.15am**

I went to 85 Dinsdale Rd with D31. As we approached the property and were walking up the driveway sighted a man and I guessed it could be D/O- John. Also sighted a vehicle parked in the driveway with Rego plate GEW339 which matches plate given by complainant.

I identified myself and confirmed it was John I was speaking to. I then ask him if he knew about a dog attack incident which happened last night which he admitted straight away to say it was his dog that had attacked the other dog but this was due to the small dog coming across the road to his car. John said that they as his wife was also present had just been up to the hospital and had come to the park to exercise their dog. He had just put his dog into the car when he heard the small dog barking at this point his dog jumped out and the two dogs ran across the road back onto the other dogs property through the open entry gate this property was 12 Valley Tce.

John then said that he ran after his dog and managed to get hold of it but was to late the damage had already been done. He also said that he had provided the other party with his contact details.

John also said that he was feeling very stressed as to what had happened.

I advised him that we will be seizing the dog due to the seriousness of the attack until I have done my investigation and then I will be able to give them an out come.

John then went and got his dog out of the car. His wife was also present at this stage who said they had put the dog into the car to keep it away from the meter reader who had just left.

John put his dog onto its lead and brought the dog out to the work truck. I observed while he was leading the dog it was acting aggressive toward me and D31 which I thought was worrying behaviour as the dog owner was present with the dog.

I filled out a seizure notice and gave to the dog owner I also provided my card plus email address and suggested to John that if he was willing for him to provided a written statement to his side of the incident, I cautioned him at this point that what he says in his statement can be used in evidence.

We then left with the dog.

Upon return to the centre we took classification photos of the dog and have confirmed the dogs identify via its microchip.

**10.46am-** Received email from D/O- John This email didn't have much relevance to the actual event only with regards to the history of his dog.

**11.52am-** John rung me on my mobile to confirm that I had received his email which I said I had but can he put more detail of what happened with the incident.

**12.18pm-** Received an updated version of John's email which has a bit more of the event.

**3.00pm**

I went to complainant's property at 12 Valley Terrace.

I have taken some scene photos which show the location of where John's car was parked and also victim's property.

I spoke to Christina and her brother Andrew Campbell who is visiting. They had already written out statements of the events last night. I have received three statements one from Christina one from her brother Andrew and also one from Christina's daughter who was also present.

I went over with them what had happened and said that it was told to me that the Chihuahua had left its property and had gone across the road and this is how the whole event started. Christina denied this as she said that her dog hadn't left the property as if it had she would of heard it barking which it did if it went out or sees other dogs. She says she never heard it barking.

Christina did confirm though that the entry gate to the property was open so her dog was free to leave and it normally sits on the front doorstep and watches out.

As Christina and family were all inside the house they only heard a man yelling and came out then to see what had happened (See attached statements for full details of their version of events).

I went over the possible outcomes and said that it will be discussed with management before any final decision is made. She wasn't happy as she thinks the other party is totally at fault but how I see it both parties were at fault due to the gate being open which means the Chihuahua has been able to freely leave the property and also let the other dog gain access. Christina has also said that she thinks it would be nice for the other D/O to contact her and apologise to her as she still thinks that they where trying to leave without trying to own up to them to what happened.

I said to her that people deal with events differently and have different levels of stress/shock so this is maybe how they have dealt with it.

Andrew has said that he went out and spoke to them this is when John has provided him with his name and phone number.

In the statements provided it has been said that John has contacted them back but has spoken to Andrew and I'm guessing that due to the event and everyone been upset the conversation would have been a bit heated so that's why John hasn't rung them back. Also in Andrews's statement he has told John to leave so this explains why he didn't hang around.

**4.00pm-**

Talked to Pete and Sue with regards to outcomes, I have said I don't think it needs to go to prosecution as both parties are at fault and the attacking dog has had no previous history with us. Also the offending D/O's have been good to deal with and have been compliant with everything being asked of them, I also think they have learnt their lesson with what has happened.

I have recommended classifying the dog on its behaviour and issuing an infringement for failing to control their dog.

**4.09pm-** I have rung and spoke to D/O- Sharon and advised her that they are able to come and collect their dog.

**4.25pm-** When Sharon has come to the centre to collect her dog I have spoken to her with regards to out come and the penalties. Went over the classification process and what is required with that. I have also provided her with the classification information sheet.

**14/12/14- 5.19pm**

Have rung Christina back and have provided her with an outcome.

Approximately 6.50pm I was in the kitchen when I heard yelling & screaming at the front of my house. I looked out the lounge window to see a medium sized man running & attempting to control his dog.

I sprinted outside to the front -

I saw a large tan dog, short hair with a studded collar, large jaws drop Lulu limp & bleeding on my

front door, where she was sitting.

The tan dog was unleashed. It had entered from the front of my property very swiftly (approx 15m from the gate).

The man hauled his dog away - I could hear yelling as he put the dog in his car & attempted to leave with his female companion.

Both middle aged - man medium build dark short hair, woman light brown/blonde.

I had picked up Lulu in my arms, holding her tight - Andrew came out & I asked him to take a photo of the car & get the guys details.

I ran inside & rang Anna Campbell (Petite Paws owner) for advice -

Lulu was wrapped in a yellow towel, her neck was limp & her body lifeless. Her stomach & intestines were hanging

out & bleeding.  
Nina was distressed & crying. We could not feel a pulse.

My parents had just arrived from Timaru & witnessed the aftermath of this scene.

Andrew came inside & said he had a photo & cell number of the guy called John.

The guy made no attempt to show remorse or concern for any of our wellbeing or the wellbeing of Lulu.

Nina & myself were very distressed, Lulu wrapped in towel & dead with no signs of life.

I rang Teri West 1959 hrs for advice as her partner Colby works for SPCA 2020 hrs Colby rang - advised me to write down all details of event & ring Animal Control & Police

2023 hrs I rang Luke (Animal Control) to report event.

2030 hrs I requested Colby to visit & take Lulu to his freezer as with the heat & her intestines/stomach exposed I presume she will decay quickly.

Prior to this I heard Andrew talking on his cellphone - he said he was talking to the guy, & told him the dog was killed & my teenage daughter was distressed. I asked Andrew what did the guy say --- Andrew said "not much I did most of the talking". The guy did not react to Andrew's earlier, last

2130 hrs

Colby SPCA arrived + took Lulu away

And took my parents to their B+B + I went + checked they got settled in to their accomodation.

2230 (ish) I phoned the police + notified them of the incident

Their dog was what I call a "muscle dog" - low fat, short hair, big head. Maybe a bull mastiff cross.

I texted John with my contact number at 1906 & didn't hear back.

I called him at 2038 & left a message on his answer machine. ~~I gave him my sister's~~

He returned my ~~ss~~ call at 2047, I gave him my sister's # & encouraged ~~by~~ him to call her, informing him that ~~the dog was~~ Lulu was dead & my niece was ~~greatly~~ greatly distressed as a result.

However he has since ~~not~~ made no contact to either myself or my sister.

He had mentioned during the incident in question that he had a 92 year old mother in cardiac care & "this was the last thing that he needed"

I didn't realise Lulu (our chihuahua) had been attacked until my mom ran back up the driveway cradling her. She was trying to hold her together, her entire side had been torn apart and had organs falling out while her head had gone completely floppy. The reason I didn't realise Lulu had been attacked prior to that was because Lulu has a very distinct screaming/screeching noise that she makes when she encounters other dogs. The other dog attacked her so fast she didn't even have time to make it. At this point we still thought Lulu might be able to make it. My mom yelled at me to go inside and get the number plate of the car. When I went to go take it down, the people had already got into their car and were about to drive away. My mom

yelled at my uncle to go out and take a picture of their car before they drove away. I wrote down the plate and went to see Lulu. My mom had wrapped her up in a towel and she was bleeding everywhere. We realised she wasn't moving.

An inter-responsive interchange had taken place between the dogs, as a consequence of which we were left in a state of profound and acute shock (to put it mildly). The whole interaction between the dogs began at the rear of our vehicle, which was parked in the entrance to the Archery Centre Park, as the road there is notified as 'No Parking' by a broken yellow line running down the street. The other dog left its resident property and crossed the road to our vehicle. I did not see the full interaction between the dogs, but intervened seconds after it had begun. The whole matter was over in moments, at with the need for prompt intervention, I could not at once check any injuries to either dog. We exchanged phone numbers with one of the occupants.



**Veterinary Report**

On the 6<sup>th</sup> January 2015 I examined the body of Lulu, a spayed female Chihuahua which had belonged to Mrs C Campbell of 12 Valley Tce, Hamilton Central.

The history had been that the dog had been attacked and killed on the 11 December 2014.

The body had been frozen but was thawed for examination and a visual assessment was made. A large abdominal wound was evident extending from the upper right side of the abdomen across the ventral abdomen through to the lower left side of the abdomen approximately 20 cm in length with two penetrating wounds through which small intestine and other abdominal organs had herniated. There was extensive damage to the abdominal organs. Also on palpation of the body the bones of the skull were found to be fractured.

In my opinion these injuries are consistent with that of an attack by a larger dog.




Dear Madam,

I have recently received from your Department, a copy of which is attached.

I wish to register the strongest possible objection to this document which misclassifies my dog as 'menacing'.

The event to which this document relates was not one in which my dog acted in any manner ordinarily threatening to any person or animal. She is by character a gentle animal, and is more timid than otherwise with other dogs.


The responsibility for this event lies with the owners of the other dog who were in dereliction of their obligations under Section 5 (b), of the Dog control Act 1996 and its amendments. Their dog was not under control as it should have been.

At the time of the incident, I was putting my dog into our car, having just taken her for a short walk, on the lead, and with no other people or animals in sight, had brought her to the car, opened the door, and was just getting her to jump up into the vehicle, as she unfailingly does, when a small dog ran across the road from a property nearly directly opposite and began an excited interaction with our dog. The brief interaction which followed would have been harmless had the animals been of more nearly equal size, and the result was accidental in nature and not the consequence of hostility.

Please note that there exists no disagreement that the owners of this dog were at that time at the rear of their property and that the gate of their section was wide open, giving their dog unsupervised and unimpeded access to the street. It was this act of negligence which brought the incident about. I exercised all reasonable care which the circumstances required. The other animal crossed the street to begin the interaction. I could not be expected to anticipate an event of this kind, having taken careful observation of the surroundings, and seeing neither animals nor humans behaved responsibly. When people allow their animals to go into the streets at will there are often negative consequences as this incident attests.

Our dog comes of docile and tractable breeds, we know this because we chose her from the litter in which she was born. She has always been registered, vaccinated, and is microchipped. She has completed the training program at the Hamilton Dog Obedience Club. She lives with three adult cats and now a young kitten as well, and has never shown any negative behaviour to any of them. We have a tame hen which we allow to walk in the garden, and she has never bothered to interact with her. She walks quietly on the lead among people in groups and is never aggressive to other dogs.

As our dog has not come into season in the last two years, it is clear that any action such as 'neutering' would be both cruel and unnecessary.



I therefore wish to lodge Formal Objection under Section 33B of the Dog Control Act 1996. I trust that the Hamilton City Council will honour its obligations under the Act as the Territorial Authority concerned, and hear my Objection.

**Classification of Dog as Menacing Dog Section 33A Dog Control Act 1996**

Section 33A of the Dog Control Act 1996 ("DCA") enables Hamilton City Council ("HCC"), to classify a dog that it considers poses a threat to any person, stock, poultry, domestic animal, or protected wildlife because of:

- a. any observed or reported behaviour of the dog; or
- b. any characteristics typically associated with the dog's breed or type.

As a result of the observed or reported behaviour HCC has classified the dog as a Menacing Dog under s33A of the Dog Control Act 1996. The Notice of Classification of Dog as Menacing Dog ("the Notice") is enclosed.

HCC requires you to have the dog de-sexed, and to provide a copy of the de-sexing certificate to HCC within one month from the date shown on the Notice.

You may be able to take advantage of discounts available through HCC for de-sexing fees with a contracted veterinarian. Microchipping is also available at the Animal Education and Control Centre. If you would like further information about these services, please contact the Animal Education and Control team on 838 6632.

Please ensure that you comply with the requirements of the classification within the timeframes outlined in the enclosed Notice to avoid any further enforcement action. If you do not agree with the Classification you may object in writing within 14 days of receiving the Classification. You must have valid ground for an objection and produce evidence that your dog is not of a breed or type listed above.



You will commit an offence and be liable on conviction to a fine not exceeding \$3,000 if you fail to comply with this requirement within 2 months after the dog is classified as menacing.

If the dog is in the possession of another person (for a period not exceeding 72 hours), you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. You will commit an offence and be liable on summary conviction to a fine not exceeding \$500 if you fail to comply with this requirement.
