 - proposals for temporary closure of any road.
- 2. Consider and determine changes to the registers and restrictions in the Traffic Bylaw and Speed Limit Bylaw, including hearing any submissions relating to those proposed changes.
- 3. Hear and determine matters arising under current bylaws, including applications for dispensation from compliance with the requirements of bylaws, unless such matters are otherwise delegated by Council.
- 4. Hear and determine other matters that require hearings or submissions, as referred by Council or other Committees.
- 5. To convene Task Force groups and carry out the terms of reference approved and referred by Council or other Committees.

The Committee is delegated the following powers to act:

- Approval of matters determined by the Committee within its Terms of Reference.
- Approval of activities and expenses relating to Task Force groups consistent with their terms of reference and approved Task Force group budget.

The Committee is delegated the following recommendatory powers:

- The Committee may make recommendations to the Council.
- The Committee may make recommendations to Committees.

Special Notes:

- The Committee may request expert advice through the Chief Executive when necessary.
- The Committee may appoint additional members for hearings where the relevant terms of reference specify the requirement for expert or external representation.

4. Confirmation of the Regulatory and Hearings Committee Meeting Open Minutes - 12 March 2019

5. Parking Restriction, Traffic and Speed Bylaw Changes

John Smulders and Melinda Deller (representing NDA) spoke to their concerns regarding the main entrance/exit easement of their business on Te Rapa Road. They requested that the proposed 'yellow lines' be extended a further 2m to increase public safety around the main entrance/exit easement of their business. They responded to questions from Committee Members concerning the current access to the business.

The Transportation Operations Team Leader spoke to the report, noting that the area to the south of NDA is being redeveloped which will require further parking restrictions and controls to be reviewed. She responded to questions from Committee Members concerning the following:

- the proposed parking restriction changes to Anglesea Street due to the redevelopment of 192-212 Anglesea Street; and
- the movement of the 'Mobility Card holders' carparks at the intersection of Victoria and Grantham street which was to further improve the safety at the intersection and make the carpark more accessible to users.

6. Objection to menacing classification - Leighton Ngawaka

Leighton Ngawaka spoke to his objection to the Classification of the dog "Bronx" as menacing. He acknowledged that Bronx had escaped from his property and stated that he now had installed fencing to prevent this from happening again. He responded to questions from Committee Members concerning the roaming history of Bronx and the new fencing at his property.

The Animal Control Manager and the Animal Control Team Leader spoke to the staff report, noting that they had not been made aware that there had been fencing installed at the property prior to the meeting. They responded to questions from Committee Members concerning the locations where Bronx had been seen roaming, the outcomes of previous complaints, and the ways in which a dog could be classified as menacing.

Purpose

- 1. To inform the Committee on the submissions received in response to Council's draft Hamilton Speed Management Plan.
- 2. To assist the hearing process and subsequent deliberations and decision making for the adoption of the draft Hamilton Speed Management Plan.

Staff Recommendations

- 3. That the Regulatory and Hearings Committee:
 - a) receives the report;
 - b) hears and considers the submissions for the draft Hamilton Speed Management Plan; and
 - c) notes that a Deliberations report on the draft Hamilton Speed Management Plan will be considered at the 18 June 2019 Growth and Infrastructure meeting.

Executive Summary

- 4. The Growth and Infrastructure Committee approved the draft Hamilton Speed Management Plan for public consultation on 29 March 2019.
- 5. The public consultation opened on 2 April 2019 and closed on 8 May 2019.
- 6. The consultation resulted in 125 submissions. Generally, the submissions were supportive. Sixteen of the submitters indicated that they wished to be heard in support of their submission.
- 7. Analysis of the results has been completed and these results along with a summary of submission comments is included in this report.

- Once these submissions have been heard, and the analysis of the results considered, the Regulatory and Hearings committee will need to provide staff direction for the preparation of a Deliberations Report which will be presented to the Growth and Infrastructure Committee meeting on 18 June 2019.

- 10. The staff recommendation to the Growth and Infrastructure committee is that the draft Hamilton Speed Management Plan be recommended to Council for adoption.
- 11. Staff consider the matters in this report have low significance and that the recommendations comply with the Council's legal requirements.

Background

- 12. At the 29 March 2019 Growth and Infrastructure Committee, a report regarding the draft Hamilton Speed Management Plan was considered along with the results of the initial engagement process that had been undertaken.
- 13. Approval to undertake formal stakeholder and community consultation was given with the focus being on the principles and prioritisation methodology contained within the draft Hamilton Speed Management Plan.

Engagement Process

- 14. The consultation commenced on 2 April 2019 with the closing date for submissions being 8 May 2019.
- 15. The consultation process included the following:
 - An online survey, via Hamilton City website 'Have your say'
 - Key stakeholders, who formed the Speed Management Plan working group, were provided with the draft plan and feedback sought from them. The working group included representatives from:
 - o Hamilton City Council Elected Members and staff
 - NZ Transport Agency (NZTA)
 - Waikato Regional Council
 - Waikato District Council
 - Waipa District Council
 - New Zealand Police
 - Waikato District Health Board
 - The Automobile Association (AA)
 - The Road Transport association (RTA)
 - Council's website and Facebook were used to promote the availability of the survey.
 - The ability to drop a pin on the online map to identify where people see speed issues.
- 16. Submitters were asked whether or not they agreed with the principles and prioritisation set out in the plan and were provided with another opportunity to show on a map where they thought speed was an issue in their community.

Summary of submissions

17. A total of 125 submissions were received. Some basic demographics of the submitters are set out below:

19. The speaking schedule for submitters who wish to present to the Regulatory and Hearings Committee meeting is included in the agenda for this meeting.

Principles and prioritisation for Speed Management in Hamilton City

- 20. Analysis of the submissions has been undertaken and is presented below.
- 21. Of the 125 responses received, 87 (70%) were in favour of the principles and prioritisation.
- 22. There were 96 comments in response to this question. General themes of the comments received were:

Those in favour of the draft plan		Those against the draft plan	
•	Areas around schools should have slower speeds	•	People already ignore the slower speed areas - they make no difference
•	Need to ensure enforcement of slower speeds Infrastructure and education required to	•	Speed is not the only solution; all road users need educating about how to use the road safely
• SI	achieve the lower speeds Slower speeds required to encourage walking and cycling	•	Lowering speeds only leads to driver frustration and an increase in unsafe practices

- 23. In addition to the above comments there were several requests for specific streets to be prioritised for slower speeds. These have been added to the requests from the initial engagement process.
- 24. There were 214 pin drops on the city map to identify areas the community had concerns with, these will be incorporated into the overall map of community requests.

- 25. Five organisations (listed below) submitted on the draft Hamilton Speed Management Plan, all were supportive of the principles and prioritisation. The Automobile Association raised a concern about the implementation and will speak to their submission at the hearing.

 - Waikato Regional Council Regional Transport Committee
 - Waikato District Health Board
 - NZ Automobile Association
 - Te Kohoa Health
