7. Waikato Regional Theatre - Update Report

Gus Sharp, from the Waikato Regional Theatre, provided an update to Members on the theatre in particular its design. He responded to questions from Members in relation to the budget for the construction of the theatre, future proofing the theatre through design, potential users and hospitality offerings that were in the surrounding area.

8. 30 Victoria Street Celebrating Age Centre Options

Concerns tenancy.

Staff Action: Staff undertook to circulate information to Members on the history of the Celebrating Age Centre in particular how it was funded.
