Indicative Project timeline

2020 - 2022

The Southern Metro Wastewater Detailed Business Case (DBC) undertaken and completed with Project Partners (Waikato-Tainui, Waikato District Council, Waipā District Council and Hamilton City Council). The Southern Wastewater Treatment Plant project identified as part of the preferred option in the DBC.

2022 – 2024

Building on the previous site selection assessment in the DBC, four of eight potential locations for the new Plant were shortlist and assessed with project partners (including Mana Whenua). Ecological monitoring, geotechnical and cultural investigations were carried out across the four sites.

• 2024

Funding approved in Hamilton City Council's 2024-2034 Long-Term Plan to progress the concept design, site master plan, designation and consenting for the project.

March 2025

131 Raynes Road was formally selected as the location for the new Plant

in collaboration with project partners.

April 2025

Beca Limited appointed as the consultant team to lead the concept design, site master plan, designation and consenting for the Project.

May- July 2025

An initial outreach to landowners living near the project site and to stakeholders was carried out to share information about the Project.

• August – September 2025

Conversations with Mana Whenua, landowners and stakeholders are ongoing. **We are here now.**

November 2025

Two community information sessions will be held, giving the community an opportunity to meet the project team, learn more about the project and modern wastewater treatment plants, and the process of designing and consenting a wastewater treatment plant.

Early - mid-2026

The community will have an opportunity to share their views on what the site surrounding the Plant could be used for.

• Mid-2026

Feedback received during the consultation period will be reviewed and used to inform the design process.

• Mid-late 2026

The design for the site will be finalised and shared with the community.

Late 2026 - mid 2027

Regular project updates will continue to be shared with project partners, stakeholders and the wider community.

• Mid-2027

IAWAI will lodge a notice of requirement to designate the land for the future construction of the Plant. Consenting and planning approvals will also be submitted.

Late-2027

IAWAI will share information with the wider community about the notice of requirement process.
