- You have the right to be heard in support of your objection and will be notified of the time and place at which your objection will be heard.

Menacing Classification under Section 33C (Breed) of the Dog Control Act 1996:

- You may object to the classification of your dog as menacing by lodging with Hamilton City Council a written objection within 14 days of receipt of the notice setting out the grounds on which you object.
- You have the right to be heard in support of your objection and will be notified of the time and place at which your objection will be heard.
- You must provide evidence that the dog is not of a breed or type listed in Schedule 4 of the Dog Control Act 1996

Dangerous Classification under Section 31(3) of the Dog Control Act 1996:

- You may object to the classification of your dog as Dangerous by lodging with Hamilton City Council a written objection within 14 days of receipt of the notice setting out the grounds on which you object.
- You have the right to be heard in support of your objection and will be notified of the time and place at which your objection will be heard.

After you make an Objection

The next step of the process is a report will be prepared by staff and submitted to the Regulatory and Hearings Committee.

You will be contacted to arrange a time and date that is suitable for all parties to allow for your objection to be heard and information regarding the process will be provided to you.
