RE: Free Parking Trial Extended - 20170

Further to your request received on 2 July 2020 for information relating to the free parking trial extension, I am now able to provide Hamilton City Council's response.

You requested:

What is the cost of 'free' on street parking per annum?

Our response:

Our response is based on the parking meter revenue associated with on-street parking in the central city.

- Prior to the 'free' parking trial from mid October 2017, on-street meter revenue averaged \$112,722 per month or \$1,352,666 per annum. Prior to the current 'free' parking trial, parking was free before 9am and after 3pm.
- Under the current 'free' parking trial (1 Nov 17 until 1 Mar 20), on-street meter revenue averages \$23,933 per month or \$287,196 per annum.

You requested:

How much has the 'free' on street parking cost since the initial trial in 2017?

Our response:

Our response is based on comparing 1) the on-street parking meter revenue received before the 'free' parking trial (when parking was free before 9am and after 3pm) and; 2) the current 'free' parking trial.

- Before the 'free' parking trial on-street meter revenue averaged \$112,722 per month (for the 12-month period prior to the commencement of the trial in October 2017).
- The current 'free' parking trial on-street meter revenue averages \$23,933 per month, which represents a net difference of \$88,789 per month.
- Based on the net monthly difference of \$88,789, for the 28 month 'free' parking trial period of November 2017 to February 2020 (i.e. pre-Covid-19), the 'free' on-street parking trial has cost \$2,486,092.

If you have any concerns with the decision referred to in this response, you have the right to request an investigation and review by the Ombudsman under section 27(3) of the Local Government Official Information and Meetings Act 1987.
