I am looking to obtain figures for the past year on Subdivision Consent processing numbers. If possible, I would like to obtain each month for the past year (July 2019 to June 2020):

Subdivision Consent applications

- Number of Subdivision Consents lodged*
- Average processing time (mean and median) for non-notified consents (working days, excluding on-hold days) for consents granted*
- Average processing time (mean and median) for non-notified consents (working days, including on-hold days) for consents granted*

223 Certificates

- Number of 223 application requests*
- Average processing times (mean & median) (working days) for certificates issued*

224c Certificates

- Number of 224c application requests*
- Average processing times (mean & median) (working days) for certificates issued*

The data provided has been produced through our business data set. Please note that the Median Working Days cannot be calculated through this reporting therefore this will only show the Average/Mean and Total days for processing.

For the 223 and 224c certificates, the time is calculated on the full certificate from 223 to 224c, which is why these are combined in the report.
