I refer to your information request below, Hamilton City Council is able to provide the following response.

1. What is the total value of all artwork owned by the Hamilton City Council?

Hamilton City Council's artwork is valued at an estimated \$21.7 million. This is based on a 2015 valuation of the Waikato Museum Te Whare Taonga o Waikato collection for insurance purposes (\$21,665,859). Insurance valuations of the Museum's collection are done around every five years. It also includes 40 artworks at Hamilton City Libraries (\$46,000).

2. How many artworks does the council own?

Council owns 5086 artworks – 5046 in the Waikato Museum collection and 40 housed at Hamilton City Libraries

3. How many artworks by Colin McCahon does the council own?

Hamilton City Council owns 13 Colin McCahon paintings.

4. When were the McCahon paintings last exhibited?

Three of the works were included in two different exhibitions at the Waikato Museum in 2019-2020.
