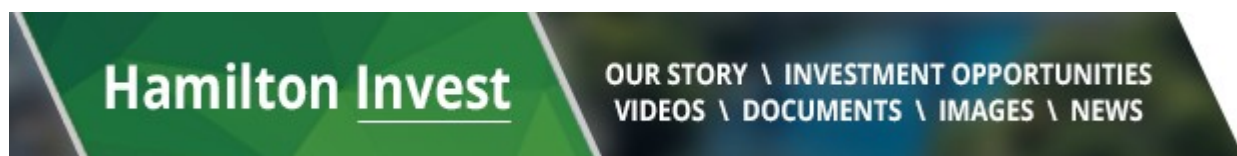

As I understood the request, you would like to have the information on Council debt shown by activity/assets – i.e. what the allocation of debt is to water, wastewater etc as at 31 January 2021. Council does not borrow for each activity it undertakes – this is done on an organisation wide basis depending on what Council requires for cashflow, when loans are due to be refinanced and a variety of other reasons that the finance team use to make decisions.

Please find attached the full list of projects that we spent funding on in the last financial year – divided between three drivers – Level of Service, Growth and Renewals.
