I refer to your **information request below in red** (and accompanying clarification). Hamilton City Council is able to provide the following response.

In terms of providing information over the span of 7 years regarding Parking Lots and Parking Buildings, this is approximately 20 consents. This part of your request can be responded to within the LGOIMA timeframe.

However, without further clarification as to what “specific activity” you are interested in, the number of consents we would need to review are **2874**. We have estimated that a single full time qualified planner, would only be able to review approximately 50 consents maximum per day. That is, putting aside his/her day to day work. That being said, it would result in approximately 58 full working days for us to provide an accurate response to your official information request.

Therefore, we are refusing your request under section 17(f) of Local Government Official Information and Meetings Act 1987 (LGOIMA).

17 Refusal of Requests

A request made in accordance with section 10 may be refused only for 1 or more of the following reasons, namely:

(f) that the information requested cannot be made available without substantial collation or research.




