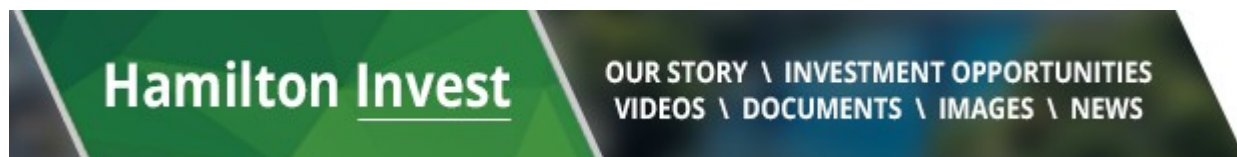

Subject: Background information for academic paper: social housing tenancy termination policies

Kia ora,

He Kāinga Oranga and associated researchers are working on a Marsden Funded set of research titled "Eviction and its consequences: representation, discourse and reality". My part in that research is to measure risk of precarious tenure. I'm using Statistics New Zealand's 2018 General Social Survey to do that.

One of the measures I need to establish is what proportion of people are in tenancies that might be ended by the landlord. So, rather than counting all people renting, I will exclude people who are renting from friends or relatives; and I will also exclude people who are renting from Kāinga Ora, since their "sustainable tenancies" policy means their tenants are extremely unlikely to have their tenancies ended.

However, I'm not sure whether or not to also exclude local authority/council housing. Are you able to tell me whether your council (or its contracted community housing providers) has in place an equivalent policy to Kāinga Ora's sustainable tenancies policy (assuming it has any council housing)?

N.B. I'm not meaning to imply any approval or criticism if you don't, and don't intend to name any councils who do or don't, just aiming to classify appropriately in the data analysis.
