Please provide the year end Innovation Park and other business entities with council involvement at the park, Profit & Loss report, Balance Sheet report and asset register for the financial years 2000 to 2020.

We have determined to release the information requested, however due to the size of these documents we have provided the following link to access the relevant documentation. Please also note, these links work best using Google Chrome. The information provided is as follows:

Hamilton City Council was not a shareholder of Innovation Waikato Ltd until 2012. Prior to 2012 Hamilton City Council provided grants to Innovation Waikato Ltd and the details of these can be located in the annual accounts. HCC had investment in the Park and shareholding up until December 2017 when Council divested its interest in the property division of the Park (i.e. Waikato Innovation Park Ltd). A summary of fixed assets is included in the annual accounts.
