



Hi,

I wonder if you can help, [REDACTED] our Director and is a registered LBP holder in F1 & F2 Foundations. He was previously working as a subcontractor however now moved on to be a main contractor for himself. He gave his LBP details to the previous company he worked for, for listing as the registered Foundations Specialist for the properties that he worked on. However we have suspicion that this company is still using his LBP Licence on Jobs that others are completing without his consent.

Would it be possible to please provide a listing of each property that [REDACTED] LBP was listed on within the last 6 months so that we are able to investigate? We need to notify the LBP board immediately if there are any properties that were not signed off by a licenced practitioner and if they had used his details without consent.

Also in the meantime is there a way that we would be able to get a notification, either by text or email whenever [REDACTED] LBP is used for a ROW? So that we can keep on top of this moving forward until this matter is cleared up?
