2. Secondly, why the 12 month rolling average to 31 March 2021 was used when Council's annual reporting is based on a June year end.

The 12 month average was then advised in the Information Request/Feedback as this is how we currently report on this metric at each Finance Committee. This was also the latest information that we had at the time it was requested for the deliberations report.


