I refer to your **information request below**, Hamilton City Council is able to provide the following response.

1. Was the He Puapua document was used in the formation of the 4 pou for Hamilton City?

No. He Pou Manawa Ora was created from strategic documents shared by our Iwi, hapuu and Maataawaka partners. It also drew on the common Treaty principles with the addition of prosperity.

2. Was the Consultation questionnaire based of the He Puapua document?

No. The questionnaire was created specific to He Pou Manawa Ora by councillors, staff, Iwi, Hapuu and Maataawaka.

3. Is the He Puapua document being currently used to formulate any recommendations from staff to Councillors.

No. Staff were not aware of the He Puapua document until receiving this LGOIMA.




