Thank you for providing that extra information, and for your patience in the matter.

Unfortunately, our Building Control team have confirmed that they are unable to supply the information you have requested, nor are they able to comment on any possible trends.

As advised before, if a Building Consent is received for a transportable home it is classified as a dwelling as consents are categorised by their intended use not by the method of construction. Therefore, Hamilton City Council does not have the ability to report on this data set specifically for transportable homes. Subsequently, we cannot comment on any trends as there is nothing to confirm any accuracy to any possible trend. We are therefore refusing this request under S 17(e) of LGOIMA as this information does not exist.

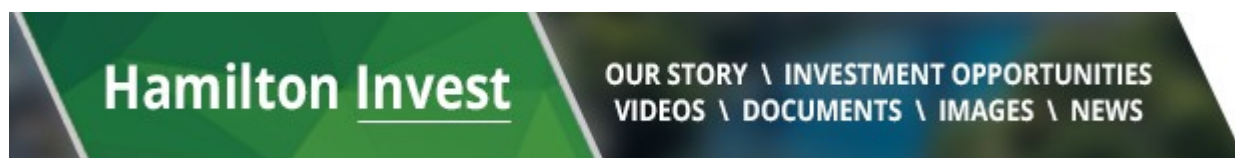
