Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Over recent years, a programme of prioritised seismic assessments have been carried out on a number of Hamilton City Council buildings.

When a Detailed Seismic Assessment (DSA) has been completed on a building, this assessment is used to determine if a seismic upgrade is required.

Regarding FMG Stadium Waikato, the aging WEL Networks Stand is one of the buildings that requires a seismic upgrade, as it needs to meet the standards of a modern stadium. Funding (\$4.52M) has been set aside in the early part of the 2021-31 Draft Long-Term Plan, which will see the stand undergo seismic strengthening. This will ensure the stand can continue operating in the short term. However, this is not a long-term solution and decisions around the long-term future of the stand will be made over the next 10 years.

The estimated cost of replacing the stand with a modern equivalent is likely to cost around \$76M, which has been included in years 11 and 12 of the capital forecasts in Council's draft 2021-2051 Infrastructure Plan. The Brian Perry Stand is another venue infrastructure set to receive seismic assessment.

A DSA is yet to be completed, meaning no decision has been made around any seismic upgrades for the Brian Perry Stand.
