Speeding tickets are issued by NZ Police as this is a moving violation and Hamilton City Council does not enforce or hold this data. Subsequently, as per S12 of LGOIMA, we have forwarded this query to NZ police for a response (see attached).

Unfortunately, this is not a request which Hamilton City Council keeps a record of. Therefore, we are refusing this request under S 17(e) of LGOIMA as this information does not exist.

Two fatal and 31 serious injury crashes have occurred involving a cyclist and a vehicle within the Hamilton City boundary, including State Highways, in the past five years from 1 January 2016 to 31 December 2020. Table 1 below shows reported crashes to NZ Police over the past five years.
