In this regard, can you please advise the name of the company and/or individual (if not a legal entity) that holds the business/health license for:

- ProfessioNail Centre Place - Shop 77, Centre Place Shopping , 501 Victoria St, Hamilton; and
- ProfessioNail Chartwell - Shop 151, Level 1, Chartwell Shopping Centre, 201 Hukanui Rd, Hamilton

**Our response:**

Your request for information is refused pursuant to section S 17(e) of Local Government Official information and Meetings Act 1987 on the grounds that the information sought is not held by Hamilton City Council. Hamilton City Council does not issue or administer permits or licences for nail salons. Accordingly we do not hold details about the ownership or legal entity of the two locations identified.

Hamilton City Council Environmental Health officers have responded to complaints about excessive smells/ fumes involving the ProfessioNail Centre in Chartwell Shopping Centre in 2007 and again in 2012. On both occasions the contact person for the salon was given as Alan Phan. No other owner or contact person details were recorded by Council staff.
