What portion of the revenue raised from parking tickets goes towards the city council, and does some - if any- go to central government?

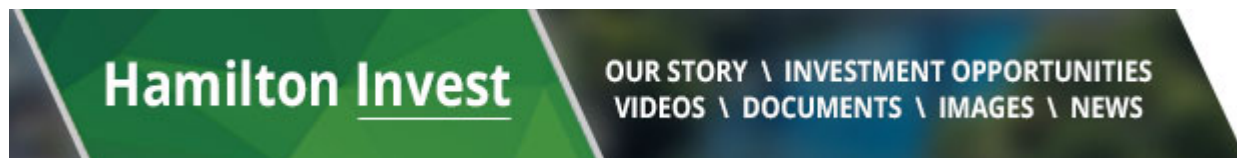

I write to acknowledge your information request of Wednesday 20 October 2021 as below.

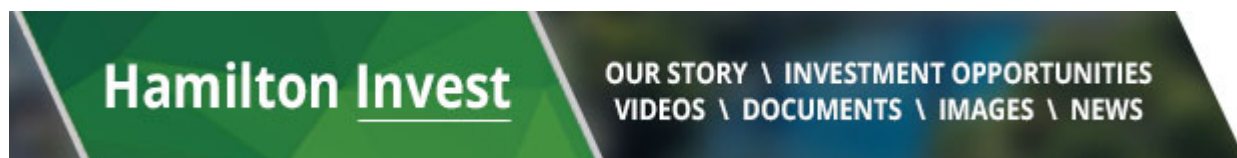
Please be advised that your request has been passed on to the relevant team within Council and you will be informed of the outcome.
