Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Thank you for contacting Hamilton City Council regarding the Vaccine Mandate.

Council acknowledges the rights of individuals and the personal choice in whether or not to be vaccinated against COVID-19.

Council also needs to do what it can to minimise the individual and community-wide harm that COVID-19 can cause as we move into the Government's Protection Framework and keep our staff, guests, and the vulnerable members of our community as safe as we can.

Rates paid to fund our facilities are fixed charges based on calculations for expenditure throughout the year. This general charge helps maintain the public facilities whether you choose to use them or not. Rates are not discounted if you choose not to or are unable to use the facilities.

We're continuing to provide services to our community in different ways where we can, including click and collect at the libraries, online access to Council meetings, and providing Zoo and Waikato Museum exhibitions virtually.

We know these are challenging times and we look forward to the day when these restrictions are no longer required.


Dear Hamilton City Council
