Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

For the 2019 Election and 2021 By-election, Hamilton City Council used the First Past the Post (FPP) model. As such, the information provided on our website (which was linked below and [here](#) again for convenience) is all the information we hold.

That being said, our 2022 election will be under the Standard Transferable Vote (STV) model and will have a similar report to that which you have provided as an example.

Therefore, we are refusing your request as per [S 17\(e\) of LGOIMA](#) – the document / information requested does not exist.


