Thank you for your overall rating of our service. We really appreciate the comment made about how our staff positively interact with your children.
Our decision to require a My Vaccine Pass was based on risk assessments of the work our staff undertake, the nature of these services and legal guidance. The risk assessments showed that all services present a risk of COVID-19 transmission. It also highlighted the need to protect Council's essential workers to keep our city's infrastructure and services running.
Getting vaccinated means people are less likely to pass COVID-19 onto other people. If people do catch COVID-19, those vaccinated are far less likely to get seriously sick or require hospital care.
Our main consideration was and will continue to be the safety of our workforce, volunteers and our community (many of whom are more vulnerable to potential COVID-19 transmission) who use our services.
