On 17 August 2021, a report about Ward Street was presented to the Infrastructure Operations Committee. The Ward Street report is Item 9 (page 48) of the [Infrastructure Operations Committee Meeting Agenda](#). Financial details of the Ward Street Innovating Streets project can be found under the 'Financial Considerations' section of the report starting on page 52.

Actual cost of the consultation process for the original layout

Response (2)

The innovating Streets for people project was managed as one project for both Ward Street and Rostrevor Street that had ongoing consultation throughout the trial period. The cost for communication, co-design, and community engagement for the project to the end of July 2021 was \$227,000, of which \$202,000 was funded by Waka Kotahi NZ Transport.

Actual cost of the re-consultation process that has led to the new layout

The costs associated with the consultation process for the interim Ward Street project have not been finalised at this present time. We are therefore refusing your request as per S 17(e) of LGOIMA – this information does not exist.

The 17 August 2021 [Infrastructure Operations Committee Meeting presented the estimated costs of all options](#). Following a final safety review, the interim design and construction costs for Ward Street are being finalised and are not yet confirmed. The current projected cost is \$360,000.


