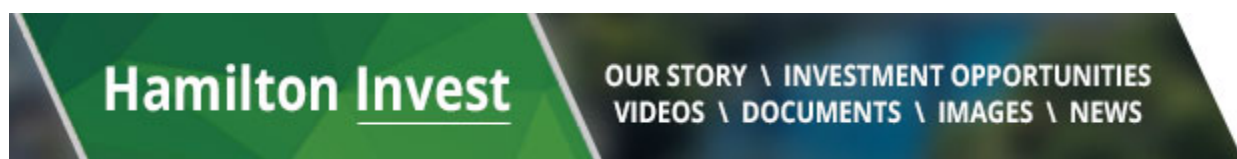

Kia ora James,
It's a difficult position we are all in now and it will take some time.

The decision of Council comes as a big disappointment for Maaori. What's hard for us to understand is the decision isn't made by us. And the Council's promise of inclusion seems far off and distant. It's also hard that the decision is delayed in the name of further discussion and conversation - but that's on a Pakeha timeline. And the comments from the Deputy Mayor are what infuriate the iwi the most.

Conversation about partnership for us began when the Treaty of Waitangi was signed in this region. Generically we say 6 Feb 1840, but that's not the date it was signed by Waikato. But, the general timeline for us is still in that era.

Maaori Wards are denied because Paakeha aren't ready for it. Doesn't make sense to us. After everything we've been through as a people, this is hard to take. It's affirmation for us that we are not at the table. This will take a lot of work to overcome and the fallout isn't over yet.

Most of this I'm sure won't come as a surprise to you. I don't know what comes next. But its important we just keep talking and working through difference.

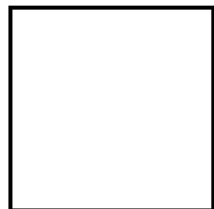
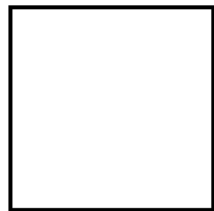

Dear Kingi Tuheitia

I write to you this evening seeking urgent assistance on an issue which is causing me great heartache.

You will know that last week a vote at Hamilton City Council, which sought to establish Māori wards in Hamilton in time for the 2022 election, failed. The vote failed because some Councillors were concerned that introducing Māori wards without having a discussion with our wider community, would be hugely divisive.

A second vote that day, proposed by me, sought to do the best I could in the circumstances given I knew the vote would be lost. It aimed to keep the issue of Māori Wards on the table, as well as undertake other actions to improve Māori representation. In doing so, Council committed to using He Pou Manawa Ora as a basis for action, knowing this strategy has been developed alongside Māori and indeed, has your personal support.

The second vote was supported unanimously by all Councillors. Nonetheless, I know that many within Māoridom, including Māori leaders for whom I have enormous respect, are bitterly disappointed my Council did not deliver the outcome they wanted. I know some people are also disappointed in me personally and I feel this very deeply. It has been an extremely challenging few days but I am utterly determined to move forward and encourage my Council to reach a decision that will be good for our entire city.

Over Easter weekend, I have done everything possible to encourage my Council colleagues to revisit this decision. While the timeframe is tight, I believe that with your support and assistance, there may be a way forward. I am very hopeful I have done enough over this weekend, and previously, to get an outcome which better reflects the desires of Māori and will culminate in Māori wards by 2022.

I am asking for your assistance to facilitate and support an urgent hui with Linda and Parekawhia, whom I have also written to. Given timing pressures (driven by legislation) I would be ready to meet at the earliest possible convenience of all parties. I appreciate your wise counsel and remain extremely appreciative of any assistance you may be able to offer.

This weekend has been a very difficult one for me, as I imagine it has been for you, your colleagues and whanau.

I have heard directly the feedback from Maaori in regard to the decisions made by Council last week, specifically from Waikato-Tainui. I know you and your people personally feel disappointed and angry; I acknowledge that and I understand that.

I am also deeply saddened by what has occurred and this weekend I have focused my energy on finding a way forward which would encourage my Council to revisit this decision.

Today I have written to Kingi Tuheitia seeking his assistance to help us find a path which I hope may lead more quickly to Maaori Wards.

I advised Kingi Tuheitia that last week I sought to do the best I could in the circumstances, given I knew the vote to introduce Maaori Wards by 2022 would be lost. My motion aimed to keep the issue of Maaori Wards on the table, as well as undertake other actions to improve Maaori representation.

While the second vote was supported unanimously by all Councillors, I know this did not deliver the outcome you wanted.

Over Easter weekend, I have done everything possible to encourage my Council colleagues to revisit this decision. While the timeframe is tight, I believe there may be a way forward. I am hopeful I have done enough over this weekend, and previously, to get an outcome which better reflects the desires of Maaori and will culminate in Maaori wards by 2022.

I have asked Kingi Tuheitia for his assistance in facilitating and supporting an urgent hui. Given timing pressures (driven by legislation) I would be ready to meet soon as possible and sincerely hope you would also be willing to do that.

I believe we all want the same thing but I will need your assistance to help me get there.

Submissions indicate support for Maaori wards

Community consultation has indicated support for enhanced Maaori representation, including Maori wards, at Hamilton City Council.

Council's consultation on Maaori wards and other means of achieving Maaori representation has closed, with 994 people sharing their voice between 16 April and 10 May.

The consultation sought a range of views on how Council can extend its commitment to making sure Maaori are best represented in its decision-making process.

Staff analysis indicates that more than four out of five people who submitted (81%) favoured Council introducing Maaori wards to achieve better representation.

Submissions in support of Maaori wards gave three clear themes for their views:

- direct input into decision making by Maaori and voting rights on Council
- addressing obligations under Te Tiriti o Waitangi
- greater Maaori representation from the community.

Another 16% of submitters indicated they did not favour Maaori wards. The themes in their submissions were:

- Maaori wards would be divisive in the city.
- Maaori can currently stand for election in existing wards.
- Maaori currently have an equal opportunity to have their say.

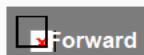
A decision on whether or not to introduce Maaori wards will be made at an Extraordinary Council meeting on 19 May.

While submitters could suggest other alternatives for Maaori representation, such as maintaining Council's Maangai Maaori model, those options won't be considered at next week's meeting.

If Council does resolve to introduce Maaori wards, a wider review of its representation arrangements would take place later this year. However, a decision to introduce Maaori wards would be binding for the 2022 and 2025 local government elections.

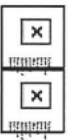

WAIKATO -TAINUI POSITION ON MAAORI WARDS

He hoonore, he kororia, he maungarongo ki te mana o te whenua, he whakaaro pai ki ngaa tangata katoa. Pai Maarire.

The purpose of this letter is to confirm for you, once again, Waikato-Tainui's position on the introduction of Maori wards across our rohe.

Waikato-Tainui celebrate the removal of legislative provisions that have allowed a percentage of the general public to deny Maaori from having guaranteed representation in local government. We acknowledge the swift action of Minister Nanaia Mahuta who has listened to the champions of this cause, despite trenchant opposition.

We are pleased that the amended legislation will be in effect for the next round of local body elections, and we encourage councils to be bold in the face of inevitable challenge. We note that Waipaa District Council has indicated that they will move to introduce Maaori wards to the Council in May 2021 and we congratulate Mayor Mylchreest and his councillors on this action.

Waikato-Tainui has advocated for representation at local government levels for many years. This work has been instrumental in establishing Maangai Maaori appointments at Hamilton City Council and Waikato District Council. Similar positions are in place at Waipaa District Council.

Maangai in these positions have voting rights on key committees, and the model works well because Maangai bring exceptional skills and experience. Their contribution also adds necessary diversity rendering local government more representative of the peoples in their communities and provides for more robust and sustainable decision-making.

We urge Councils to retain these positions even if they vote to establish Maaori wards. We look forward to discussing our views with councils in our rohe at our joint hui at our Tribal Parliament next week.

Local government decisions affect our everyday lives. The inclusion of Maaori in all levels of decision-making goes some way for Councils to act honourably and in accordance with the provisions of Te Tiriti o Waitangi. Inclusion also aligns with international Indigenous rights instruments adopted by the New Zealand government.

Maaori have rights to a decisive voice in decisions that affect us directly. Moreover, it makes sense for us to work together with local communities in the governance and management of the landscapes and ecosystems we live in and near. For these reasons, it is critical that Maaori are at the forefront of co-designing the proposed new legislative regime for resource management that is being progressed at haste

We commend this legislative change as a step in the right direction. Having said that, we would like to see further improvement.


Following a legacy of having been denied the right to vote, Maaori have guaranteed seats for Maaori in Parliament to ensure participation. We are of the view that there should also be guaranteed seats on every council. We have a successful model operating at Waikato Regional Council where two Maaori wards have been in place for some years and we recommend this model as a way forward for councils when they come to consider the establishment of wards.

This is an opportunity for local government to give effect to the promise of partnership.
