I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Hamilton City Council has done a comprehensive search of its online and physical records / archives. Unfortunately we were unable to locate the original lease document.

With regard to your second enquiry – Hamilton City Council holds no documents which establish that Council took ownership of the building at a point in time prior to 16 October 1996.

Therefore, as per [S 17\(e\) of LGOIMA](#) we are refusing your request as this information cannot be located.

I'm hoping you might be able to help me or to put me in touch with someone who can. I have a customer who is trying to clarify the legal ownership of the Celebrating Age Centre. There are two documents or agreements in particular that he is trying to track down;

- A copy of a lease agreement which was signed between HCC and the Waikato Region Old People's Welfare Council on 5 May 1978
- According to the HCC minutes for 16 Oct 1996, HCC took over responsibility for the premises. This was in response to a recommendation from the Older People's Working Group. Did this mean that HCC took ownership of the building, and if so, is there a document showing this?

Really grateful for any help you can provide. We haven't been able to find anything in the archives here around either of these points
