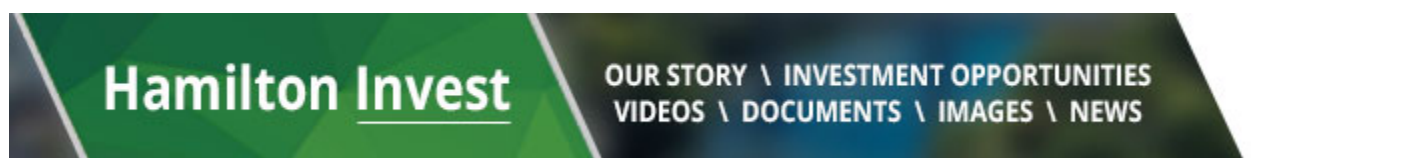

Could you please acknowledge receipt of this request.

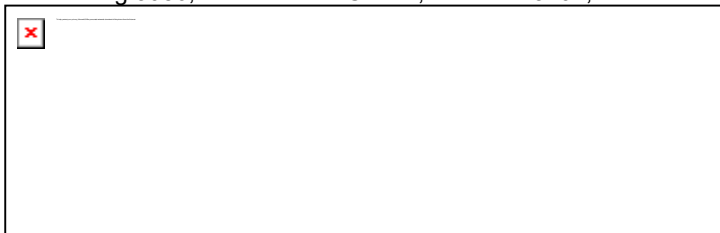
Also, if all or part of the information requested cannot be provided I would like a written reason why.
