I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Your Request 1:

How many cars does your council own that are used by the mayor?

Our Response 1:

Hamilton City Council owns 1 car that is used by the Mayor.

Your Request 2:

How many cars does your council own that are used by the Chief executive?

Our Response 2:

Hamilton City Council leases (not owns) 1 car that is used by the Chief Executive.

Your Request 3:

How many cars are owned that are to be used by any other members of the council's executive leadership?

Our Response 3:

Three of the Executive Leadership Team (ELT) have individual employment agreements which include the use of a Council-leased vehicle. The rest of the Executive Leadership Team are unknown.

Your Request 4:

How many times has the council rented cars for any elected members in the year to date?

Our Response 4:

Hamilton City Council has not organised any rental cars for Elected Members in the year to date.

Your Request 5:

What are the costs of purchasing, leasing, maintenance, fuel or any other related costs of each of the aforementioned answers?

Our Response 5:

Hamilton City Council is currently going through contract updates for the four leased vehicles so costs will change. Please see below for the costs to date:
