Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

The above folder contains the decisions which relate to resource consent applications that have a split zoning on the site - Natural Open Space and General Residential. The predominate zoning is General Residential with a portion of each site zoned Natural Open Space (some more so than others). As such, the Residential Zone rules have been applied to the dwellings that are contained within the residential zone areas of the site, as if they were a restricted discretionary activity. Further, we have also only applied the deposit fee for a restricted discretionary activity, not a non-complying activity. This is considered a pragmatic and sensible approach to the split zoning on each site.


