Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

In addition to the final response we sent you on Friday regarding your information request received on 02 May, please find the rest of the information you have requested.

### Your request 2:

In the last financial year, what percent of resource consents are processed within the statutory timeframe?

- In the last financial year, what was the Median charge per non-notified consent?
- In the last financial year, what was the Median charge per notified consent?

### Our Response 2:

In the last financial year (Jul 20 to Jun 21) 87% of resource consents (land use, subdivision and change of conditions) were processed on time. For the 2021/22 financial year the number of resource consent processed within time is 97%.

- In the last financial year the median charge per non-notified consent was \$2,040
- In the last financial year the median charge per notified consent was \$2,690

Please note that median charge provided in the response above was calculated using the charge for the deposit fee for the resource consent only and does not include any subsequent charges i.e. additional monitoring or consultants fees. If you require any further information in relation to the median charge per resource consent please advise us, however further calculation of these figures will take additional time.

**Your Request 1:**

In the last financial year, what percent of building consents are processed within statutory timeframe?

**Our Response 1:**

96.5% of building consents (including amendments) were granted within the statutory timeframe between the period of 1 July 2020 and 30 June 2021.

**Your Request 2:**

In the last financial year, what percent of resource consents are processed within the statutory timeframe?

- In the last financial year, what was the Median charge per non-notified consent?
- In the last financial year, what was the Median charge per notified consent?

**Clarification and Extension required :**

With regards to part 2 of your request for information we are seeking some clarification. As currently framed this request may involve substantial collation. Due to the substantial amount of work that would be required we would like to confirm the scope of your request (please refer to section 17(f) and 17B LGOIMA). Are you able advise whether you are requesting:

1. The charge to issue the consent by this I mean the final total that was billed once the consent was granted; or
2. All fees relating to all charges including after the resource consent is granted to monitor and issue these 224/CCC certs.

We are still processing this final part of your request and the request necessitates a search through a large quantity of information and meeting the original time limit would unreasonably interfere with the operations of the local authority we are requesting an extension of time per [s 14\(1\)\(a\) LGOIMA](#) until 14 June 2022.

Can you please respond to the OIA team via this email address on the matter of the clarification by 03 June 2022. If it would be of assistance we are happy to call you to discuss this further.

**Your Request 3:**

In the last financial year, what was the total staff turnover for the council?

### Our Response 3:

Total staff turnover for Council in last financial year was 23.6% for the financial year ending 30 June 2021.


