Our Response

Kerb discharge, stormwater and wastewater connection details are available online via the public CityWaters Viewer (<https://www.hamilton.govt.nz/our-services/water/citywatersviewer/Pages/default.aspx>). Levels, locations and dimensions of works shown on the viewer may not be accurate due to circumstances that have not been notified to Council. A physical check should be made on all levels, locations and dimensions before starting design or works.

Hamilton City Council has no record of any site specific testing (ground discharge testing details) being completed for 29-31 Crawshaw Drive. This will have to be completed as part of any future development. Therefore we are not able to provide this information as it does not exist per [s17\(e\) of LGOIMA](#).
