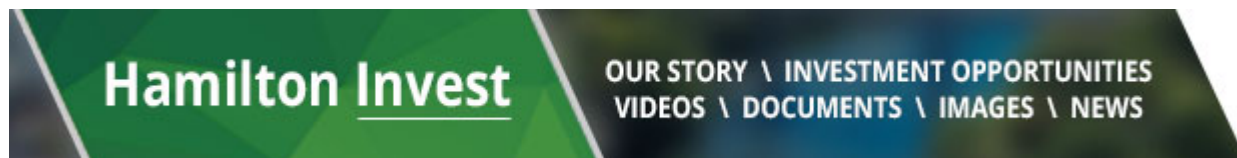

I refer to your official information request dated 16 May 2022.

You requested information of use by Hamilton City Council of Organic Weed Control including those provided by Weedtechnics, specifically your request for information (over 12 months OR for the 20/21 Financial Year) of:

- All pesticides (including herbicides, insecticides, fungicides and rodenticides) used by the council, its agencies and contractors;
- The volume of each of these pesticides used; and
- The purpose of each product and where they are used.

As currently framed, while we are prepared to release this to you, the information you have requested will involve substantial collation.

Due to the substantial amount of work that would be required we would like to confirm the scope of your request and whether this can be narrowed (please refer to section [17\(f\)](#) and [17B](#) LGOIMA).

This could mean considering:

- shortening the timeframe for the information requested e.g. to nine or six months;
- discussing with staff whether parts of your request could be prioritised - i.e. are some pieces of information more important to obtain than other aspects of your request;
- narrowing the areas of Council that you would like to obtain this information for – e.g. rodenticides are used in our open spaces as well as our buildings. If you were researching use of rodenticides in open spaces and not enclosed buildings such as our main office this would assist to reduce the amount of collation required for your request; and/or
- extending the timeframes for providing information to you.

Council has the ability to decline your request in full or part due to substantial collation under section [17\(f\)](#) of the LGOIMA, however we would like to work with you to see if the scope of your request can be narrowed.

Can you please respond to the OIA team via this email address on the above by 01 June 2022. If it would be of assistance we are happy to call you to discuss this further.
