Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

Your request:

I would like to request a record of how many times the HCC has provided council owned or operated security camera footage to Police, both proactively as well as upon request. An example being that if there was a break-in in plain view of the camera, if the police request this footage was provided to the Police when they asked, that would be one count. If a security officer noticed the issue and proactively sent it to Police (if that even happens?) that would be another count. For timeframe, going back over the last 3 years ideally.

Our Response:

Our records show that the total number of times CCTV footage has been supplied to police from the Hamilton City Council over the past 3 years is as follows:

Our Venues, Tourism and Major Events (VTME) group has confirmed they hold no data in relation to your request. No records were kept for any years prior to 2022, we are therefore refusing this aspect as per S 17(e) of LGOIMA.

On two occasions, NZ Police visited our VTME premises to view CCTV footage to see if there is sufficient evidence before requesting a copy/record of the CCTV footage. In both those instances, the CCTV footage was not deemed sufficient and therefore a formal request was not received.


