Your request 2:

Please provide the number of new “unit title” sections that HCC approved in the period 2005 to 2021 on an annual basis. I understand that new unit titles become available when HCC provides the developer with the 224 F certificate.

Our Response 2:

New titles are issued from LINZ when the 224C Certificate is signed by Council. It is through this process new residential properties records are created, rather than the 224F Certificate.

The 224F Certificate being part of the final process (associated with the S233 process for Unit Titles) which is signed by Council, relates to Council being satisfied that that the apartment building complies with or will comply with the provisions of the building code described in [section 116A](#) of the Building Act 2004.

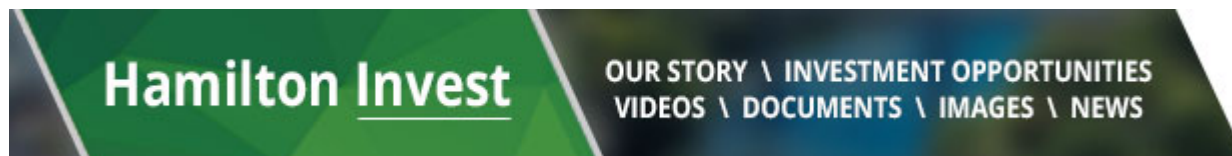
