Kia Ora,

I refer to your **information request below**, Hamilton City Council is able to provide the following response.

### Your request:

I have heard that the Hillcrest Bowling Club at 111 Cambridge road is going to be removed and water towers put in. We have had no official communication about this and when it will take place and what will actually be going onto this site. Please could I be sent some information on the new water towers and what the time frame is?

### Our Response:

As you might know the Hillcrest Bowling Club activities that include the likes of three greens, clubhouse and parking areas are located on a number of land parcels owned by council. This includes specifically, Lot 2 DP36078 which is designated to secure its future use for Water Storage and Supply. Currently a non-operational reservoir can be seen sitting next to one of the bowling greens.

We are in the process of considering our water infrastructure work programmes for the next 10 years (2024 to 2034) and have signalled that there will be a need to utilise the property for a new and/or expanded water storage reservoir.

You might also be aware that the land is leased out by our Parks team for the use of the bowling club. This lease is due for renewal and as such the Council team met with representatives from the Bowling Club (30 June 2022) to provide early awareness that this water storage project is being looked into as this will influence the lease renewal process.

At this point in time, subject to funding, it is too early to confirm exact dates. We are currently talking to our Parks team to make sure proper process will be followed in accordance with the lease.

At this point in time, we are refusing your request as per S 17(e) of LGOIMA as the information you have requested does not yet exist.

We are unable to provide any information to you relating to impacts of any reservoir on the site at this time, as a significant amount of work will be required to understand this. The earliest that funding could be confirmed to progress this project would be July 2024. Following confirmation of funding we would expect that there would be time to undertake the necessary work and consult with affected parties prior to considering the lease and how this might be managed.

Circumstances may change over time, in terms of this programme. If that happens we will be in contact with the bowling club in the first instance given the lease arrangements
