Thank you for your request below. Hamilton City Council provides the following response.

**REQUEST:**

Can I ask about the daily/weekly traffic amount in Wairere road outside the badminton stadium (Eastlink hub)?

**CLARIFICATION:**

I'd like to know the weekly traffic on Wairere Dr between Clyde street and Ruakura Rd/Te Aroha St over the last 6 - 12 months.

**OUR RESPONSE:**

While we ordinarily have this information on the Open Data Portal ([here](#)), there are detector issues with the signalised crossing just south of Old Farm Rd. To still provide you with some data, we have used approach detectors at Wairere/Ruakura and Wairere/Clyde instead. The attached is the weekly total volume from April 2022.
