**H3 Venues**

The city's major event venues at Claudelands, FMG Stadium Waikato and Seddon Park. For the purposes of this response, we have not included the use of fungicides at these specialist venues as they don't fall under the descriptions you have asked for information on. We can confirm that at times it is used to treat specific specialist turf damage caused by fungi. However, if you would like to receive more information on use at these sites, please advise.


