Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

Could you please provide me a list of waste management providers contracted by your council over the last five years. Please use [this form](#) for each provider to tell me:

- Date when contract started
- Date when contract ends
- how much funding each entity has received each year for the last five financial years, and how much it is expected to receive in the next five financial years
- A brief description of what the money is for

Our response:

The online form did not allow for two contractors to be entered. We have had two in the time frame requested.

Name of Organsation: Hamilton City Council

Name of waste management contractor:

Hamilton City Council has used two waste management providers over the period of time indicated in your request – Waste Management (NZ) Ltd (1 July 2002 until 30 August 2020) and Enviro NZ Services Limited (31 August 2020 and expires on 31 August 2030). Up until August 2020, our kerbside services with Waste Management included a black bag for general rubbish, and a mixed crate for recyclables, including glass. Our new kerbside system started in August 2020 with Enviro NZ which includes a 120L wheelie bin for rubbish, 240L wheelie bin for recycling, glass crate and a 23L food scraps bin. This enables us to collect more recyclables and divert more waste from landfill.

Briefly describe what the contractor is required to do for the council:

Waste Management weekly kerbside collection of rubbish (2 black bags) and kerbside recycling collection (45L crate mixed recycling, including glass plus cardboard). Processing and sale of recycling collected. Operation of the Lincoln Street Resource Recovery Centre, operation of the Hamilton Organic Centre, illegal dumping collection, supply of 45L recycling crates and collection of rubbish and recycling from Council facilities.

Enviro NZ: fortnightly kerbside collection of rubbish (120L wheelie bin), mixed kerbside recycling collection (240L wheelie Bin) and glass collection (45L crate). Weekly food scraps collection (23L

bin). Processing and sale of recycling and food scraps collected. Operation of the Lincoln Street Resource Recovery Centre and operation of the Hamilton Organic Centre. Providing of a bin inspector, collection of illegal dumping. Supply of wheelie bins, glass crates and food bins. Collection of rubbish and recycling from HCC facilities.

When did the current contract with this contractor start?

Our contract with Waste Management ended 30 August 2020 and our current contract with Enviro NZ began 31 August 2020
