**How many Waste Transfer Stations are there within your area? (Please list)**

Within Hamilton City Council boundary there are three waste transfer stations:

- Lincoln Street Resource Recovery Centre
- Waste Management Edgar Street Transfer Station
- Hamilton Refuse and Recycling Transfer Station

Please note there are also two transfer stations adjacent to Hamilton City Council's boundary, in the Waipa District Council. These are the Hamilton Organic Centre and Waste Management Resource Recovery Park. As these two facilities are outside of Hamilton City Council's boundary they have not been included within the below data.

Please also note that Waste Management Edgar Street is not a site managed or owned by Hamilton City Council or contractors.

**What materials are they permitted to handle?**

**Lincoln Street Resource Recovery Centre** – Waste dropped off by the public, recycling, kerbside collection waste, glass and food scraps collections and commercial waste.

**Waste Management Edgar Street Transfer Station** – Commercial waste.

**Hamilton Refuse and Recycling Transfer Station** – Kerbside mixed recycling and Commercial waste/recycling.

**Lincoln Street Resource Recovery Centre** – Residential sections were established first.

**Waste Management Edgar Street Transfer Station** – Transfer Station was established first.

**Hamilton Refuse and Recycling Transfer Station** – Residential sections were established first.


