We refer to your information request below. Hamilton City Council provides the following response.

**Your request:**

- 1. The total revenue accrued from fines for vehicle with current registration failing to display vehicle registration for each of the years 2021, 2022, and 2023.*
- 2. The total revenue accrued from fines failing to display vehicle registration for each of the years 2021, 2022, and 2023.*

**Our response:**

Hamilton City Council does not issue infringements for the offence P411: Failed to display a current vehicle licence, as per the question above. Therefore, the revenue generated during the periods of 2021, 2022, and 2023 for this parking infringement is \$0.

The total revenue accrued from fines failing to display vehicle registration for each of the years 2021, 2022, and 2023.

Hamilton City Council checks the status of vehicle licences and, where licences have lapsed, issues infringements for the following offences:

- P402: Operated an unlicensed motor vehicle (where vehicles licences have lapsed by less than 12 months)
- P401: Operated an unregistered motor vehicle (where vehicle licences have lapsed by more than 12 months)
