We refer to your information request below. Hamilton City Council provides the following response.

Your request:

Market Economic prepared reports as required by these legislation titled: HDCA 5th July 2021 and Residential Capacity Feasibility Modelling 8th Feb 2023.

Kia ora,

We refer to your information request below.

Our IS team have completed a search of Council records and have advised that there are approximately 6376 items of correspondence that could relate to your request for information below. While Council would likely make a decision to release information to you, each item would need to be reviewed in order to make a decision on any redactions. For this reason, your request may be refused in accordance with S 17(f) of LGOIMA – substantial collation.

Hamilton City Council can also consider charge for making the requested information available under the LGOIMA charging policy, which you can view [here](#), the policy allows for the first 3 hours free and then a charge of \$38 per **half an hour**.

Based on reviewing 6376 items the cost would be substantial, and . We estimate that the maximum charge will be in the order of **\$24,000**. Please see calculation breakdown below:

6376 items of correspondence x 3 minutes of approximate review per correspondence =
19,128 minutes of review in total
19,128 minutes of review / 60 minutes = 318.80 hours
318.80 hours – 3 free hours = 315.80 hours of review in total
315.80 hours of review in total

\$38 per half an hour = \$76 per hour

315.80 hours of review in total x \$76
= **\$24,000.80**

The estimated 3 minutes per correspondence is to account for reading, reviewing, converting to PDF and redacting where necessary.

Staff ask that you consider refining your request to be more specific so we can reduce the amount of correspondence required for review by close of business Monday 7 August.

If you wish to discuss this decision with us, please email officialinformation@hcc.govt.nz and one of the team will arrange a call with you to discuss any change or refinement of your request in order to substantially reduce the scope of your request and discuss any charge.
