Our response:

Cost of purchase of land (underlying current Transport Hub facility) :	\$2,958,659.31
Final construction cost (excluding land purchase):	\$13,021,062.01 excl GST

Please note that both the land and the construction of the Hub attracted an enhanced Financial Assistance Rate from Waka Kotahi of 75.5% leaving Council's share of the above costs at 24.5%.
