We refer to your information request below. Hamilton City Council provides the following response.

Your request:

With regard to the relocation of toilets at Callum bare park I would like to see the following

- *Budgeted cost*
- *Reasons given for the reason for the work*
- *Who approved this decision and if signed off by council how each member voted in respect of that decision*
- *Scope of works to be undertaken.*

Our response:

The Callum Brae Park toilets are part of our [Long-Term Plan](#) 2021 – 31.

- The Budget is **\$436,054.00** – This includes consents, construction, installation, removal of exeloo, landscaping and Geo Tech report.
- We have an obligation to renew our facilities as they age. Under the Long-Term Plan, you will find the Infrastructure Strategy 2021 – 51, which discusses our obligation to maintain our assets. This facility was of an age where it was due for renewal.
- Our Elected members did not vote specifically on the park itself but the Long-Term Plan as a whole [here](#).

Please see the attached for the design plans of the new toilets. As part of any renewal, we assess whether the current facilities are fit for purpose. In this case, we looked at the location of the current toilets right up against the car park and determined that a more suitable location would be nearer the playground – improving the safety of the facility for parents and young children.
