Kia ora,

We refer to your information request below. Hamilton City Council provides the following response.

Your request:

We request the latest available data (and the previous 5-year period) on road vehicle traffic counts for the Claudelands' zone of River Road, Hamilton, from Te Aroha Street to and including Miripiko Kindergarten, for the following time periods (can be adjusted to council's time of data capture):

- *Monday to Friday all day 7am to 6pm.*
- *Peak hours of 7am to 9am and 4pm to 6pm Monday to Friday.*
- *Saturday and Sunday, all day from 7am to 6pm.*
- *We also request results from any traffic modelling that has been done by Hamilton City Council or other parties on traffic effects to River Road relating to any proposed development of Sonning Car Park in River Road.*

Our response:

Traffic counting on our roads are undertaken at various times based on traffic volume. The location you refer to is completed every alternative year as per the data provided.

Included are programmed reports for 2017 and 2019 from traffic counter. In 2021 our traffic counting consultant used a different counting technology and there is a spreadsheet from that counter included. A Special Count was done in 2022 which has also been included. Traffic counting data for 2023 is not yet available.

On 18 November 2022 we stopped conducting traffic surveys and instead we now use data from recently installed traffic signal detectors, so included is a spreadsheet showing the data collected since its inception up to and including 2 September 2023.

Your request:

We also request results from any traffic modelling that has been done by Hamilton City Council or other parties on traffic effects to River Road relating to any proposed development of Sonning Car Park in River Road.?

Our response:

Hamilton City Council is unaware of any traffic modelling associated with this site. The development proposals for the site did not include traffic modelling. Therefore, we are refusing this request in accordance with S17(e) – this information doesn't exist.

1. This is a request for information under the OIA and the LGOIMA
