**Our response:**

Hamilton raised safety platforms are a combination of Waka Kotahi and Hamilton City rates.

This is a recognised method of managing speed and therefore the outcome of any crash.

Hi.

In recent weeks I have used the Claudelands Bridge, whilst travelling Southward on Victoria Street & then a LH. Turn onto the Claudelands Road - Bridge.

I NOTE the Hump/Bump @ the Victoria Street set of Traffic Lights, prior to turning left onto said Claudelands Road, is missing the 'Odd section of Tapered Rubber Ramp', this gives one a distinctly annoying abrupt 'Bump Rise' in any vehicle..... Even travelling lower than the recommended speed limit.

Maybe you need to put a sign up, 'TAKECARE Damaged Obstacle Ahead'.

I look forward to the Replacement/Repair of this Missing item.

My preference would be to remove this wasted item, as I recall as, One Makes a turn in a vehicle then it is prudent for one to slow down & possibly Brake as required to negotiate any change (especially a 90-degree corner) of direction, so the need for a Hump/Bump is negated....

Please forward this to the correct Department. Thank you.

I would be interested in discussing with someone as to the Cost of numerous Hump/Bumps installed like a Forrest of Obstacles across our Hamilton City. (I'm sure the Emergency Services are really impressed by your initiative).

Having recently returned from the UK (Population of 67 million....), covering an extensive Road Travel. I did NOTE ONE installed Hump/Bump.

It is indeed amazing as this is a Growth Industry (Has the HCC got shares in the Contractors?).

Are all these Raised Hump/Bumps, Courtesy Crossing paid for by HCC Rate Payers? Who decided this is such a great idea?

As to the horrendous Costs of the various variety of 'Combos' created?

The additional Cost of obvious ongoing Repairs & Maintenance. Well done, brilliant.

As far as Courtesy Crossings go.... These appear to be an extremely expensive device/reminder of possible Pedestrians in the area.

#### Pedestrian Crossings:

*I have not been advised of any RADICAL changes to the Road Code.*

*I'm sure that a set of WHITE lines, with roadside signage & even in the Past a set of 'Belisha Beacon' – Amber Coloured Globe or alternative, mind you a possible target for vandals - pre-warning of a ZEBRA Crossing is still applicable to both Drivers & Pedestrians.*

#### NZ Road Code pedestrian crossings (extracts from web...):

Marked pedestrian (zebra) crossings. At zebra crossings with no traffic island, stop and give way to people walking on any part of the crossing or who are waiting to cross. Some zebra crossings have a traffic island in the middle. Stop and give way to people walking on your half of the road or who are waiting to cross.

#### Who has right of way at a pedestrian crossing NZ?

*If there's no raised traffic island in the middle of the crossing, stop and give way to pedestrians on any part of the crossing. wait until the pedestrian has crossed in front of you and is clear of your vehicle before you proceed.*

Do pedestrians always have right of way at a crossing?

If vehicles are approaching wait for them to pass or stop before stepping out and then take a life saving second look before crossing. Vehicles must give way to pedestrians on any part of the crossings.

I would also convey my concern that we have a Grandson with Cerebral Palsy, his Mother has a Van to accommodate his electric wheelchair. He does not have the muscular control of his limbs & neck that a normal vehicle passenger has.

Effectively, there is a 'WHIPLASS' effect of his Head when negating your Citywide Obstacles course.

I would say that long-term ACC will be involved in his life due to sustained repetitive injury.

I look forward to discussing these issues
