We refer to your information request below. Hamilton City Council provides the following response.

Your request:

I am hoping you can help me with a left field question or point me in the right direction. I have been asked by a business in town about Council cost increases that relate to staff, as in what is the % cost increase for labour and how much of that relates to the health offering versus salary cost? I am not sure if this information is available but would appreciate it if you could let me know.

Our response:

HCC have budgeted 5.6% for salary/wage adjustment for the financial year ending 30 June 2025, as well as including the increase cost of continued health insurance, which represents 0.31% increase to staff costs. The combined labour cost increase is therefore 5.91% combined. This is still to be confirmed.
