We refer to your information request below. Hamilton City Council provides the following response.

Please see the table below this is the workings, and the list of transactions requested. Our CCO's will respond directly.

**Written response:**

- Taituarā does not meet the legal definition of a CCO. It is the individual not the council that is a member of Taituarā. No local authority or group of local authorities own or control 50 percent or more of the voting rights at any meeting of Taituarā, nor does any local authority or group of local authorities have the right to appoint 50 percent or more of the members of our governing body.
- Members of Taituara derive professional benefit from access to resources, relevant updates and training opportunities and the ability to network across the sector. There is no advocacy on behalf of any employee or group of employees relating to employment conditions.
- No deductions are made from employees pay as the membership is deemed to be a professional membership which is part of their role at Council.

Payments for membership are also made to professional bodies such as the Law Society, Chartered Accountants ANZ, IPENZ - Engineering NZ, NZ Planning Institute etc as part of generally standard market conditions of employment for roles where a professional qualification or registration is required to be maintained.
