We refer to your information request below. Hamilton City Council provides the following response.

Your request:

Proportion of Consents Granted in Hazard Areas

Please provide the following information for the years 1991 – 2023 (inclusive), or the years within that period for which such data is available:

- What proportion of the building consents for new dwellings granted by this local government authority this year were granted on land recognised under the current District Plan as subject to significant natural hazard risk?*

This could include, but is not limited to, land within the following areas:

- Flood plains*
- Flood prone areas*
- Evacuation zones*
- Areas of coastal inundation*
- Erosion zones.*

Please also provide a breakdown by individual risk type, e.g.

- % of BCs for new dwellings with high riverine flooding risk,*
- % of BCs for new dwellings with high coastal inundation risk,*
- % of BCs for new dwellings with high landslide risk,*

Our response:

The following sets out the number of buildings consents for new dwellings for the years 2013-2024 which have been approved on sites which also have a hazard overlay as part of the Operative District Plan, and the total number of building consents for new dwellings approved for each year.

This information covers all of the hazard area overlays which are identified in the Hamilton City Operative District Plan; however, this does not necessarily mean that these are considered to be 'significant natural hazard risk'. Only the years 2013-2024 are provided as the Operative District Plan was notified in December 2012 which is when some of the Hazard overlays would have had legal effect.

The information is also only able to provide the number of building consents on properties which also have a hazard overlay under the District Plan; however, it cannot confirm whether the building is actually located in the overlay area. We are not able to easily obtain the numbers of building consents where the building is located within the hazard overlay on the site, this would involve manually checking each of the building consents identified and cross referencing this with the hazard overlay area.

We would estimate this would take approximately 15min per consents which given the total number of consents identified is 623 this would take staff 155.75 hours. Even if we were to charge for this information the team would not have capacity to fulfil this request. Therefore we are refusing in accordance with s17(f) of LGOIMA – substantial collation.

If you have a specific consent / address that you would want this information on we can do upon request. Let us know by replying to this email.
