We refer to your information request below. Hamilton City Council provides the following response.

**Your request:**

*Could you please advise how many playgrounds the Hamilton City Council has built in the last five years, and the cost involved.*

**Our response:**

Over the last five years Council has renewed/re-built thirty-one of the existing eighty-eight playgrounds within the city. Included in this eighty-eight are two new playgrounds that have been completed within the last five years. Costs of these works over five years is \$14,308,455. Note this figure excludes the cost of the latest new playground at Rototuna Village where the project closure is still underway, and the total costs are currently not available.
